- All parties stipulate there was no written partnership agreement. The Court finds there was no requisite meeting of the minds and therefore, determines that each party was responsible for bearing 1/3 of the costs of settlement of debts. The following indicates the amounts owed by Defendant Hedlund.
 - Each party was responsible for paying 1/3 of \$1,187,741.00 [\$1,2181,741 \$94,000 payment made on August 1, 2003 to be credited below] for settlement of HHKT's Creditors. Defendant Hedlund having previously contributed \$342,084 owes **\$53, 829.67.** [\$395,913.67 - \$342,084]

 - f. Defendant Hedlund is solely responsible for the \$2,090 interest payments made on his personal capital loan.
 - Judgment is granted for the Plaintiffs and against the Defendant on the Plaintiffs' 2.
 - complaint for \$352,246.67. Judgment is granted for the Plaintif's and against the Defendant on the Defendant's 3. Counterclaim.
