WHEREAS, there has been filed with the Village Clerk of the

NOW, THEREFORE, BE IT ORDAINED, by the President and Board of Trustees of the Village of Roselle, DuPage and Cook Counties, Illinois, as follows:

SECTION 1: That said petition is hereby found to be in due and proper form and the required notice has been given to Roselle Fire Protection District No. 1 and the Schaumburg Township officials.

SECTION 2: That said territory is not within the corporate limits of any municipality but is contiguous to the Village of Roselle.

SECTION 3: That said territory which is hereinafter legally described is hereby annexed to the Village of Roselle, DuPage and Cook Counties, Illinois:

Legal Description The South 260 feet of the North 1040 feet (measured on the West line thereof) of that part lying East of the West 840 feet (measured at right angles to said West line) of the East 1/2 of the Southeast 1/4 of Section 34, togecher with the South 260 feet of the North 1040 feet (measured on the West line thereof) of that part lying West of the West line of the East 60 acres thereof of the West 1/2 of the Southwest 1/4 of Section 35, Township 41, North, Range 10, East of the Third Principal Meridian, in Gook County, Illinois.
