ORDER

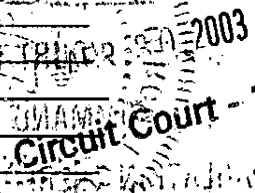


