1. The Bank, as of the date hereof, has advanced the additional principal amount of <u>THIRTY-SEVEN THOUSAND SEVEN HUNDRED EIGHTY-FIVE AND 98/100</u> Dollars (\$37,785.98) ("Additional Advance"). Pursuant to the Additional Advance, the outstanding principal balance of the Note and Mortgage are hereby increased to <u>TWO HUNDRED FORTY-EIGHT THOUSAND AND 00/100</u> Dollars (\$248,000.00).
