3, 4, 6, 8, 12, 15 AND 16 ON ORIGINAL COMPLAINT 1-16
17 OPEN ITEMS ON 1ST AMENDED COMPLAINT, 1-24.

IT IS HEREBY ORDERED that any and all motions to vacate fine(s) entered in this matter are hereby denied, AND SAID FINES SHALL STAND AS FINAL JUDGMENT(S).

AND, IT IS FURTHER ORDERED that the judgment(s) hereby entered on the date(s) of 10-25-94 in the total amount(s) of \$3,400.00 plus \$60.00 in court costs against defendant(s) GORDON JENKINS shall stand as final judgment(s) and that leave for enforcement on said judgment(s) is granted Plaintiff, CITY OF CHICAGO, instanter.

Count II is hereby dismissed without prejudice.

AND IT IS FURTHER ORDERED that a Mandatory Permanent Injunction issue against defendant(s) GORDON JENKINS his/her/their agents, heirs successors or assigns, to fully comply the open City of Chicago Building Violations in this Cause, stated above.
