IT IS HEREBY ORDERED that any and all motions to vacate fine(s) entered in this matter are hereby denied.

AND, IT IS FURTHER ORDERED that the judgment(s) hereby entered on the date(s) of *8/14/94* in the total amount(s) of \$ *21500.00* plus \$60.00 in court costs against defendant(s) *Frederic J. Miller* shall stand as final judgment and that leave for enforcement on said judgment(s) is granted Plaintiff, CITY OF CHICAGO, instanter.

Count II is hereby dismissed without prejudice.

AND IT IS FURTHER ORDERED that *Frederic J. Miller* his/her/their agents, heirs successors or assigns, be and are permanently enjoined and restrained from renting, leasing, using or occupying the subject premises until full compliance of CITY OF CHICAGO Codes as stated in this cause and further Order of this Court.

The Court reserves jurisdiction of this matter for the purposes of modification, enforcement or termination of this permanent injunction.

IT IS FURTHER ORDERED that this cause is hereby dismissed subject to the above permanent injunction, and, the above lien and personal judgment(s) against the named defendant(s) in the aforesaid amount(s).

This order is final and appealable, the court finding no just cause or reason to delay its enforcement or appeal.
