That said Owner is entitled to credits on account thereof as follows, to wit: \$400.00.

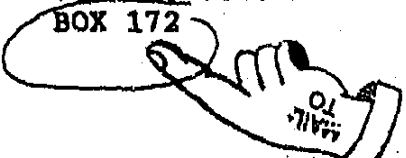
