LEGAL DESCRIPTION FOR THE 104 Contempury Court Figury 11.

PARCEL 1:

Unit 10 A1-1 in Oakwood Hills Condominium as delineated on a survey of the following described real estates: Certain Lots in Final Plat of Oakwood Hills Unit 1, being a Subdivision of part of the South 1/2 of Section 18 and part of the North 1/2 of Section 19, all in Township 41 North, Range 9 East of the Third Principal Meridian in Cook County, Illinois; which survey is attached as Exhibit "B" to the Fifth Amended Declaration of Condominium Ownership recorded July 8, 1994 as Document Number 94596804, amending the Declaration of Condominium Ownership recorded the 21st day of September, 1993 as Document Number 93756478; together with an undivided percentage interest in the common elements appurtenant to said unit as set forth in said Declaration, as amended from time to time.

PARCEL 2

The exclusive right to the use of Garage Space G 10 A1-1, a limited common element, as delineated on the survey attached to the Fifth Amended Declaration of Condominium Ownership recorded July 8, 1994 as Documera Number 94596804, amending the Declaration aforesaid recorded September 21, 1993 as Document Number 937565478.

- I. Grantor also herby grants to the Grante, its successors and assigns, as rights and easements appurtenant to the above described real estate, the rights and easements for the benefit of said property set forth in the Declaration of Condominium aforesard, and Grantor reserves to itself, its successors and assigns, the rights and easements set forth in said Declaration for the benefit of the remaining property described therein.
- 2. This Deed is subject to all rights, easements, covenants, conditions, restrictions and reservations contained in said Declaration the same as though the provisions of said Declaration were recited and stipulated at length herein.
