#### LOAN MODIFICATION AGREEMENT

This Agreement entered into this 30th day of November, 1994 by and between FIRST UNITED BANK, an Illinois banking corporation, herein called "Bank" and FIRST UNITED BANK, as Trustee under Trust No. 1469 and dated November 10, 1988 herein called "Borrower", C.M.S. DEVELOPERS, INC. and CLYDE D. SANA, herein collectively called "Guarantors".

WHEREAS, C.M.S. Developers, Inc. and Clyde D. Sana, are Guarantors of the indebtedness due the Tank by Borrower; and

WHEREAS, Borrower desires to modify certain provisions of the Mortgage and Assignment of Rents recorded in the Office of the Recorder of Deeds of Cook County, Illinois; and

WHEREAS, the Bank is willing to make certain modifications to the provisions of the above Mortgage and Assignment of Rents as herein set forth below.

NOW THEREFORE, in consideration of the mutual covenants herein contained and other good and valuable consideration, it is mutually agreed by and between the undersigned parties as follows:

- 1. The foregoing preambles are incorporated by reference and made a part hereof.
- 2. The legal description of said Mortgage and Assignment of Rents are hereby amended to add the following described property to wit:

- 5. The Borrower agrees to pay all legal fees and costs in conjunction with the preparation, execution and implementation of this Loan Modification Agreement.
