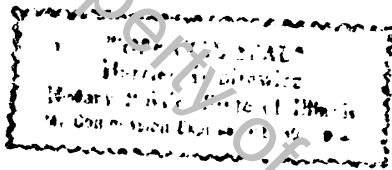

LEGAL DESCRIPTION:
