29# This Loan Modification Agreement ("Agreement"), made this 29 day of 100%, 2003, between Brett R Lettiere and Leslie A Lettiere ("Borrower") and Charter One Mortgage Corp. In consideration of the mutual promises and agreements exchanged, the parties hereto agree as follows (notwithstanding anything to the contrary contained in the Note or Security Instrument):

- After the application of all payments due on the Note through and including August 1, 2003, the amount payable under the Note and the Security Instrument (the "Unpaid Principal Balance") will be U.S. \$144,880.95 consisting of the unpaid amount(s) loaned to the Borrower by the Lender, including advances, if any, and any interest capitalized to date, to which Mortgagor has no defenses, offsets or counterclaims.
- Borrower promises to pay the Unpaid Principal Balance, plus interest, to the order of the Lender. Interest will be charged on the Unpaid Principal Balance at the yearly rate of 5.375%, from August 1, 2003. Borrower promises to make monthly payments of principal and interest of U.S. \$819.71, beginning on the first day of September 1, 2003, and continuing thereafter on the same day of each succeeding month until principal and interest are paid in full. - Nothing in this Agreement shall be understood or construed to be a satisfaction or release in whole or in part of the Note and Security Instrument. Except as otherwise specifically provided in this Agreement, the Note and Security Instrument will remain unchanged, and Borrower and Lender will be bound by, and comply with, all of the terms and provisions thereof, as amended by this Agreement. with, áll Agreement.
