

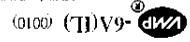

25. Placement of Collateral Protection Insurance. 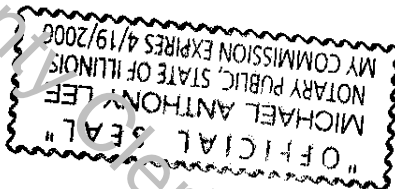


