

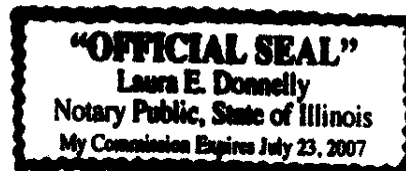

ORDER

This Cause coming before the Court for hearing on Heidi's Petition for Support and her Petition for Fees, the Court having a ~~partial~~ ^{partial} conference and being otherwise fully advised in the premises;

IT IS HEREBY ORDERED AS FOLLOWS:

1. Nick shall pay to Heidi the sum of \$1,700 per month retroactive to April 1, 2003. The issue of retroactivity to Dec 2, 2002 is reserved for future adjudication. ^{for child support} EACH PARTY TO ASSESS AND PAY FROM EACH YEAR. Nick owes Heidi the sum of \$5,100 for child support, taking into consideration the \$900 paid to Heidi during June, 2003 and leaving a balance due of \$4,200.
