  - A. The maturity date is hereby extended to January 31, 1997.
  - The monthly payment is hereby modified from \$1,314.65 to \$1,530.98 principal and interest.
  - C. The Mortgage Note balance is hereby increased by Nineteen Thousand And No/100 Dollars (\$19,000.00) and funds credited to Mortgagor's building account
- Except as herein expressly modified, all of the terms, covenants, conditions and 3. warranties of the Mortgage, Mortgage Note, and Loan Modification Agreemnt shall continue to remain in full force and effect.
