#### MODIFICATION AND EXTENSION AGREEMENT

THIS AGREFMENT made as of this 30<sup>th</sup> day of January, 2004 between REPUBLIC BANK OF CHICAGO, an Illinois banking corporation, hereinafter called Bank, and ENRIQUE OJEDA, JOSE LUIS OJEDA, AND CELESTINO OJEDA (herein called "Original Guarantors"), RUTH KALL, BASILIO ZUNIGA, AND DEBORAH ZUNIGA (herein called "Rep'ace nent Guarantors"), and GOOD SHEPHERD CHURCH OF GOD 7<sup>TH</sup> DAY, an Illinois not-for-profit corporation, the Owner of the property and/or the Obligor under the Note, and hereinafter called Second Party, WITNESSETH:

THAT WHEREAS, Bank is the owner of that certain Note in the amount of \$182,000.00 dated May 26, 2000, secured either in whole or in part by a Mortgage and Assignment of Rents recorded as Document No 00451444 and 00451445, respectively, covering the real estate described below:

WHEREAS, Second Party has requested that Bank modify the terms of said Note and Mortgage by substituting certain guaranties, the rate of interest charged under the note, extending the maturity thereof, and as otherwise set forth herein;

NOW THEREFORE, in consideration of ONE DOLLAR (\$1.00), the covenants herein contained and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto agree as follows:

- 1. As of the date hereof, the amount of the principal indebtedness is ONE HUNDRED SIXTY FIVE THOUSAND FIVE HUNDRED FORTY-NINE AND 65/100 DOLI ARS (\$165,549.65)
- 2. The Interest Rate of such Note is hereby reduced from the existing Interest Rate of 9.0% to the new Interest Rate of 6.75% effective February 1, 2004.
- 3. The maturity date of the Note and Mortgage hereinbefore described is hereby extended from June 1, 2005 to February 1, 2009.
- 4. The new monthly payment will be in monthly installments of principal and interest in the amount of One Thousand Four Hundred Seventy-Three and 20/100 Dollars (\$1,473.20) each beginning March 1, 2004 and continuing on the 1<sup>st</sup> day of each and every month thereafter, except that all sums due shall be due and payable on February 1, 2009.
- 5. Second Party has requested that Original Guarantors to eleased as guarantors by the Bank and Replacement Guarantors be substituted as guarantors in their stead. The Replacement Guarantors agree to be bound by all the terms and conditions of said commercial guaranties as if original parties thereto and to except new substitute guaranties. Furthermore, Replacement Guarantors acknowledge having reviewed the loan documents and agree to their terms and to be bound by the same.
- 6. This agreement is subject to Second Party paying Bank a documentation fee of \$250.00.
- 7. This agreement is subject to Second Party paying Bank a renewal fee of \$500.00.

Second Party and Replacement Guarantors warrant and certify that the indebtedness evidenced by the Note is a valid and subsisting debt of the Obligor and in all respects free from all defenses, setoffs and counterclaims both in law and equity, as is the lien of the Mortgage.

In all other respects, the Note hereinbefore described and all mortgages, documents and/or instruments securing the same shall remain unchanged and in full force and effect.

Notwithstanding the foregoing, Second Party and each Replacement Guarantor expressly waive any defense which it now has or may have or assert. Furthermore, in order to induce Bank to enter into this agreement, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Second Party and Each Replacement Guarantor does hereby release, remise and forever discharge Bank of and from any and all setoffs, claims, counterclaims, demands, causes, causes of action, suits and/or judgments which it now has or may have against Bank including but not limited to matter casing out of the Note and/or any document, instrument or agreement securing the same or arising out of any banking relationship existing between the parties.
