## **ASSIGNMENT AND REDESIGNATION OF LIMITED COMMON ELEMENT**

**THIS ASSIGNMENT AND REDESIGNATION OF LIMITED COMMON ELEMENTS** (this "Assignment") is entered into this 10<sup>th</sup> day of October, 2003, by South Campus Development Team, L.L.C., an Illinois limited liability company ("SCDT"), as Declarant, and Michael Chatterton and Renee Chatterton ("Assignee") as fee owner of the Unit described herein.

### **RECITALS:**

**A.** SCDT is the Declarant under that certain Second Amended and Restated Declaration of Condominium for The University Village Lofts, dated as of July 16, 2003, and recorded July 17, 2003 as Document No. 00319810029, as amended from time to time (the "Declaration"), which governs certain real property legally described therein. Capitalized terms not expressly defined herein shall have the meanings ascribed to such terms in the Declaration.

**B.** As of the date hereof, Assignee is the fee owner of Unit 612-P, more particularly described on Exhibit A attached hereto.

**C.** Pursuant to the Declaration, the Parking Space designated on the Plat as B48 is currently designated as a Declarant Parking Space.

**D.** Under the terms of Section 3.7(c) of the Declaration and otherwise in accordance with the terms of Section 26 of the Condominium Property Act of the State of Illinois (the "Act"), SCDT desires to assign the foregoing Declarant Parking Space as more particularly described hereunder.

**NOW, THEREFORE**, in consideration of the recitals set forth above and the mutual covenants and agreements hereinafter set forth, and for Ten and No/100 Dollars (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, SCDT, as Declarant, and Assignee, as fee owner, as set forth above, agree as follows:

1. SCDT, as Declarant, hereby assigns, conveys, transfers and sets over unto Assignee, as the fee owner of Unit 612-P, all of its right, title and interest under the Declaration with respect to the Parking Space designated as B48, such that Parking Space B48 shall hereafter be a Limited Common Element appurtenant to Unit 612-P.

2. In accordance with Section 26 of the Act and Section 3.7(c) of the Declaration, SCDT hereby certifies that a copy of this instrument has been delivered to the Board. For purposes of Section 3.7(c) of the Declaration and Section 26 of the Act, this instrument shall constitute an amendment to the Declaration for the limited purposes described in this Assignment. Nothing contained herein shall modify the Undivided Interest appurtenant to the Units.

3. This Assignment shall be binding upon and shall inure to the benefit of Assignee and its successors and assigns with respect to the foregoing Unit.

### LEGAL DESCRIPTION OF PROPERTY

#### PARCEL 1:

Unit 612-P in the University Village Lofts Condominium as delineated and defined on the plat of survey of the following described parcel of real estate:

Lots 1 and 4 and Outlots A and B and part of Outlot C in Block 3 of University Village, being a subdivision in the Northeast 1/4 of Section 20, Township 39 North, Range 14, East of the Third Principal Meridian, according to the plat thereof recorded December 18, 2002 as document 0021409249, in Cook County, Illinois, together with all rights appurtenant to the foregoing property pursuant to that certain Nonexclusive Aerial Easement Agreement dated June 26, 2001, and recorded June 28, 2001 as document number 0010571142.
