#### RESTATED MORTGAGE AND ASSIGNMENT OF LEASES

THIS RESTATED MORTO GE AND ASSIGNMENT OF LEASES (hereinafter referred to as this "Mortgage") is made as of December \_\_\_, 2002 between EUGENA SULLIVAN and WILLIAM J. SULLIVAN, his wife (singularly a "Mortgagor", and collectively, the "Mortgagors"), with a mailing address at 10400 S. Maplewood Avenue, Chicago, Illinois 60655, and PURITAN FINANCE CORPORATION ("Mortgagee"), with a mailing address at 55 West Monroe Street, Chicago, Illinois 60603;

WHEREAS, pursuant to that certain Continuing Guaranty date May 08, 2002 (the "Guaranty"), William J. Sullivan (along with other guarantors named therein) uncondutionally guaranteed to Mortgagee the payment and performance of all indebtedness, obligations and liabilities of M.I. DAIRY SERVICE, INC., an Illinois corporation ("Borrower") to Mortgagee, whether now existing or hereafter created or arising, including, without limitation, a revolving line of credit loan in the principal amount of \$600,000.00 extended by Nortgagee to Borrower (such loan as modified or restated from time to time, the "Revolving Loan") (under which loan Morigagee shall make advances to Borrower from time to time, not to exceed \$600,000.00 at any time), evidenced by Borrower's Promissory Note dated May 08, 2002, in the principal sum of Six Hundred Thousand and 00/100 (\$600,000.00) Dollars (the "Note"), payable to the order of Mortgagee on , 2003, plus interest payable monthly on the unpaid principal balances thereof outstanding from time to time calculated at the applicable variable rate per annum set forth in the I ote, subject to the interest rate floor provided therein (the terms of the Note being incorporated herein by reference). The Note shall bear interest after default calculated at the applicable variable rate set forth in the Note (the "Default Rate"), and

WHEREAS, to secure repayment of the Note, the Guaranty and other indebtedness mercin described, Mortgagors executed a certain Mortgage and Assignment of Leases dated as of May 08, 2002 (the "Original Mortgage") mortgaging, granting and conveying to Mortgagee the Mortgaged Premises as defined in the Mortgage and Assignment of Leases, including the real estate described in Exhibit A attached hereto and incorporated herein by reference; and

WHEREAS, Mortgagors have asked WASHINGTON MUTUAL BANK F.A. ("Senior Mortgagee") to refinance the existing first mortgage on the Mortgaged Premises; and

WHEREAS, Senior Mortgagee is requiring Mortgagee to release the lien of the Original Mortgage, as a condition of such refinancing by the Senior Mortgagee; and

WHEREAS, to induce Mortgagee to release the Original Mortgage, Mortgagee requires Mortgagors to execute and deliver to Mortgagee this Mortgage, in substitution for the Original Mortgage; and

WHEREAS, Mortgagee will not release the Original Mortgage unless Mortgagors agree to execute and deliver this Mortgage;

NOW, THEREFORE, in consideration of Mortgagee's concurrent release of the Original Mortgage and intending this Mortgage to be recorded in substitution for the Original Mortgage, Mortgagors, to secure: (a) the payment of the principal and interest on the Note, with interest, when the same becomes due and payable (whether by lapse of time, acceleration or otherwise), including, without limitation, all extensions, renewals, modifications, refinancings, amendments, and consolidations thereof or thereto (and Mortgagors hereby acknowledge and irrevocably agree that this Mortgage shall automatically secure any and all extensions, renewals, modifications, refinancings, amendments, and consolidations of the loan evidenced by the Note); (b) the payment of all other indebtedness, obligations and liabilities which this Mortgage secures pursuant to any of its terms, including, without limitation, all expenses and charges, legal or otherwise, including reasonable attorneys' fees, paid or incurred by the Mortgagee in realizing upon or protecting this Mortgage or the Induction diness secured hereby; (c) the payment and performance of the Guaranty; and (d) the performance of Mortgagors' covenants and agreements under this Mortgage, do hereby GRANT, MORTGAGE, CONVEY AND ASSIGN to Mortgagee, it successors and assigns, the real estate described in Exhibit A attached hereto and incorporated herein by reference, being situated in the County of Cook, State of Illinois; and

TOGETHER WITH (1) all buildings, improvements, fixtures, appurtenances, easements and hereditaments thereto belonging; and together with all equipment and machinery now or hereafter therein or thereon used to supply heat, gas, air conditioning, electrical, sprinkler systems, rumbing, water, light, power, refrigeration and ventilation; communication and electronic monitoring equipment, tanks, pumps and together with any other fixtures, equipment, machinery or other personal property now or hereafter placed on the allove described property which shall be employed in connection with the operation, use, occupancy or enjoyment thereof; (2) all right, title and interest of Mortgagors, including any afteracquired title or reversion, in and to the rights-of-way, loads, streets, avenues and alleys adjoining the Mortgaged Premises; (3) all rents, issues, proceeds and profits accruing and to accrue from the Mortgaged Premises and all right, title and interest of Mortgagors in and to any and all leases approved by Mortgagee now or hereafter on or affecting the Mortgaged Premises, whether written or oral, and all other leases and agreements for the use thereof, and all renewals, extensions and substitutions thereof (all of the foregoing collectively, the "I eases"), together with all security therefor and all monies payable thereunder, subject, however, to the conditional permission of Mortgagee given to Mortgagors to collect the rentals to be paid pursuant thereto, provided Mortgagors shall not be in default hereunder; and (4) all proceeds heretofore or hereafter payable to Mortgagors by reason of loss or damage by fire and such other hazards, casualties and contingencies insured pursuant to the insurance policies hereinafter described and awards and other compensation heretofore or hereafter payable to Mortgagors for any taking by condemnation or emine a domain proceedings of all or any part of the Mortgaged Premises or any easement or appurtenance thereof, including securance and consequential damage. (said real estate and all of the above collectively referred to herein as the "Mortgage's Premises")

TO HAVE AND TO HOLD the Mortgaged Premises unto Mortgagee, its successors and assigns forever, provided, however, that if and when all principal and accrued interest on the Note and all other indebtedness and obugations hereby secured shall be paid in full, and Mortgagors shall perform all of the terms, covenants and agreements contained herein, then this Mortgage shall be released upon the written request and expense of Mortgagors.

Mortgagors covenant that Mortgagors are lawfully seized of the real estate hereby conveyed and have the right to mortgage, grant and convey the Mortgaged Premises; that the Mortgaged Premises are unencumbered, except for the existing mortgage(s) described in **Exhibit B** attached hereto (the "Senior Mortgage"), and that Mortgagors will warrant and defend generally the title to the Mortgaged Premises against all claims and demands, subject to any declarations, easements and restrictions of record existing on the date hereof, approved by Mortgagee.

As provided in Section 8 hereinbelow, the total amount of indebtedness secured by this Mortgage may increase or decrease from time to time, but the total unpaid balance so secured at any one time shall not exceed a maximum principal amount of Six Hundred Thousand and 00/100 (\$600,000.00) Dollars, plus interest thereon, and any disbursements made by Mortgagee for the payment of taxes, special assessments, or insurance on the Mortgaged Premises, or to protect the Mortgaged Premises or the lien of this Mortgage, with interest on all such disbursements calculated at the Default Rate, and all costs of collection and of foreclosing this Mortgage, including reasonable attorneys' fees.

#### MORTGAGORS HEREBY FURTHER COVENANT TO MORTGAGEE AND AGREE AS FOLLOWS:

- Mortgagors hereby agree: (a) to pay when due all indebtedness secured by this Mortgage, all interest thereon and all other indebtedness, obligations and liabilities which this Mortgage secures; (b) not to commit or permit to exist any waste of the Mortgaged Premises (non-payment of taxes or cancellation of insurance shall each constitute waste) and to keep the Mortgaged Premises in good condition and repair; (c) to keep the Mortgaged Premises free of any mortgage, trust deed, assignment of leases and rentals, security agreement, mechanic's lien, or other lien or encumbrance (except this Mortgage and the Senior Mortgage); (d) not to suffer or permit unlawful use or any nuisance to exist upon the Mortgaged Premises; (2) not to remove or demolish any part of the improvements of a structural nature which would adversely affect the va'ue of the Mortgaged Premises; (f) not to abandon the Mortgaged Premises; (g) to pay when due any indebtedness or liability vinich may be secured by a mortgage, lien, other encumbrance or charge on all or any part of the Mortgaged Premises equal or senior in priority to this Mortgage; (h) to complete within a reasonable time any buildings or improvements now or at any time in the process of erection upon the Mortgaged Premises; (i) immediately after destruction or damage to all or any part of the Mortgaged Premises to commence and promptly complete the rebuilding or restoration of buildings, im progrements and all other property now or hereafter on the Mortgaged Premises unless Mortgagee elects to apply the proceeds of insurance to the indebtedness secured by this Mortgage as hereinafter provided; (j) to comply with all laws, regulations, rulings, ordinances, orders and all other requirements imposed by any governmental or other competent authority and with all restrictions, covenants and conditions relating to the Mortgaged Premises or to the use of thereof; (k) that no construction shall hereafter be commenced upon the Mortgaged Premises unless the plans and specifications for such construction have been submitted to and approved in writing by Mortgagee to the end that such construction shall not, in the reasonable judgment of the Mortgagee entail prejudice of the loan evidenced by the Note and this Mortgage; and (l) that if the Mortgaged Premises are now or hereafter located in an area which has been designated as a flood risk area by the Director of the Federal Emergency Management Agency or as otherwise required by the Flood Disaster Protection Act of 1973 (ar ar nended from time to time) and regulations issued under it (collectively, the "Act"), the Mortgagors will keep the Mortgaged Premises covered for the duration of the loan evidenced by the Note by flood insurance up to the maximum limit of coverage available under the Act.
- Mortgagors shall keep the Mortgaged Premises continuously insured for the benefit of Mortgagee, until the 2. indebtedness secured hereby shall be paid in full and discharged, against fire and such other hazards and risks customarily covered by the standard form of extended coverage endorsement available in the State of Illinois, including risks of lightning, windstorm, malicious mischief, vandalism and other extended coverage hazards, for full replacement value, and such other appropriate insurance as the Mortgagee may require from time to time A1 insurance policies and renewals must be acceptable to Mortgagee, must provide for payment to the Mortgagee in the event of loss, must require thirty (30) days notice to the Mortgagee in the event of non-renewal or cancellation, must be written by insurers acceptable to Mortgagee and have such monetary limits as Mortgagee shall require, and must be celivered to the Mortgagee. Should the Mortgagors fail to insure or fail to pay the premiums on any insurance or fail to deliver the policies or certificates or renewals to the Mortgagee, then the Mortgagee at its option may have the insurance written or renewed and pay the premiums for the account of Mortgagors. In the event of loss or damage, the proceeds of the insurance shall be paid to the Mortgagee alone. No loss or damage shall itself reduce the indebtedness secured hereby. All casualty policies shall contain a standard mortgagee clause naming Mortgagee as "Mortgagee and Loss Payee" and a Lender's loss payable endorsement in favor of Mortgagee. Mortgagors shall also provide a Comprehensive General Liability Policy naming Mortgagee as an "Additional Insured", written by an insurer acceptable to Mortgagee and having such monetary limits as Mortgagee shall require.
- 3. In the event of any loss or damage sustained by casualty for which insurance policies are in effect, the Mortgagee is authorized, subject to the rights of the holder of the Senior Mortgage, to adjust, compromise and collect all

claims thereunder without the consent of the Mortgagors and to execute and deliver on behalf of Mortgagors all necessary proofs of loss, receipts, vouchers, releases and such other documents as shall be required by the insurers to be executed. At the election of Mortgagee, the proceeds of any insurance may be applied to the reduction of the indebtedness secured by this Mortgage, whether or not then due, or may be applied to the cost of building or restoring of buildings and improvements on the Mortgaged Premises, or may be applied to both purposes in such proportion as the Mortgagee shall determine. That part of the Mortgaged Premises so damaged or destroyed shall be repaired or rebuilt, in accordance with plans and specifications therefor submitted to and approved by Mortgagee (which approval shall not be unreasonably withheld or delayed) and all life, safety and environmental regulations, laws,ordinances (including zoning), rules and regulations of governmental authorities having jurisdiction thereover, so as to be as similar, as is reasonably possible, to the condition which existed prior to such casualty.

- 4. Me 'gg gors shall pay all general real estate taxes, special taxes, special assessments, water and sewer charges and all other taxes and charges on the Mortgaged Premises before any charge for nonpayment attaches or accrues, and shall furnish the 'no tgagee, upon request, with the original or duplicate receipts therefor. If Mortgagors shall desire to contest any tax or special assessment, to avoid default under this Mortgage, Mortgagors shall pay such tax or assessment in full in the manner provided by law.
- If Mortgagors fail to perform any of their obligations under this Mortgage, or if any action or proceeding is commenced which materially affects Mortgagee's interest in the Mortgaged Premises (including, but not limited to, a lien priority dispute, eminent domain, cookemnation, code enforcement, insolvency, bankruptcy or probate proceedings), then Mortgagee, at its sole option, may make per arances, disburse sums and take any action it deems necessary to protect its interest (including, but not limited to, the disbursement of reasonable attorneys' fees and paralegals' fees, the entry upon the Mortgaged Premises to make repairs, the full or partial payment of principal or interest on prior encumbrances, the payment of delinquent taxes and insurance premions and the purchase, discharge or settlement of any tax lien or any other prior lien or claim, or the redemption from any tax sale or forfeiture affecting the Mortgaged Premises or the contest of any tax or assessment). All monies paid or it curried by Mortgagee in connection therewith including costs and reasonable attorneys' fees and any other monies advanced by Mortgagee to protect the Mortgaged Premises shall be so much additional indebtedness secured hereby and shall be in mediately due and payable by Mortgagors together with interest at the Default Rate defined herein.
- 6. In the event that the Mortgaged Premises or any part thereof is taken by condemnation, Mortgagee is hereby empowered, subject to the rights of the holder of the Senior Mortgage to collect and receive any awards resulting therefrom ("Awards"), which shall, at the election of Mortgagee, be applied to the payment of the Note or any other indebtedness secured hereby, or on account of rebuilding or restoringthat part of Mortgaged Premises not so taken or damaged. If Mortgagee elects to permit the use of Awards for rebuilding or restored on the Mortgaged Premises, the Mortgaged Premises shall be so rebuilt or restored in accordance with plans and specific wions therefor submitted to and approved by Mortgagee (which approval shall not be unreasonably withheld or delayed) and applicable laws, so as to be as similar, as is reasonably possible, to the condition which existed prior to condemnation. In the event the Awards are insufficient to pay for all costs of rebuilding or restoration, Mortgagors shall deposit with Mortgagore an amount equal to such excess costs prior to any disbursement.

To further secure payment of the Note, all other indebtedness secured hereby and performance of all of the terms, covenants, conditions and agreements contained herein, Mortgagors hereby sell, assign and transfer to Mortgagee all of their right, title and interest in and to all Leases and rentals, issues, proceeds and profits now due and which may hereafter become due pursuant thereto, it being the intention hereby to establish an absolute transfer and assignment thereof to Mortgagee. Mortgagors hereby irrevocably appoint Mortgagee their agent, in their name and stead (with or without taking possession of the Mortgaged Premises), to rent, lease or let all or any part of the Mortgaged Premises to any party or parties, at such rental and upon such terms as Mortgagee shall, in its discretion, determine and to collect all of said avails, rents, issues and profits arising from or accruing at any time hereafter and all presently due or which may hereafter become due pursuant to each and every Lease or any other tenancy existing or which hereafter exists on the

Mortgaged Premises, with the same rights and powers and subject to the same rights and powers as Mortgagors would have. If no Event of Default under this Mortgage has occurred, Mortgagors shall have the right to collect all of the rents arising from Leases or renewals thereof. Upon an occurrence of an Eventof Default, Mortgagee, at any time or times thereafter, may notify any and all of the tenants of the Leases that the Leases have been assigned to Mortgagee and Mortgagee may direct said tenants thereafter to make all rentals and payments due from tenants under the Leases directly to Mortgagee and shall have the right to enforce the terms of the Leases and obtain payment of and collect the rents, by legal proceedings or otherwise in the name of the Mortgagors. Mortgagors will at all times deliver to the Mortgagee duplicate originals or certified copies of all leases, agreements and documents relating to the Mortgaged Premises and shall permit access by the Mortgagee to its books and records, insurance policies and other papers for examination and making copies and extracts thereof. The Mortgagee, its agents and designees shall have the right to inspect the Mortgaged Premises at all reasonable times and access thereto shall be permitted for that purpose.

This Mortgage is given to and shall secure not only existing indebtedness, but also future advances, and this Mortgage secure; at such advances, whether such advances are obligatory or to be made at the option of the Mortgagee, or otherwise, as are made within twenty years from the date hereof, to the same extent as if future advances were made on the date of the execution of this Mortgage, although there may be no advance made at the time of execution of this Mortgage, and although there may be no indebtedness outstanding at the time any advance is made. The lien of this Mortgage shall be valid as to all such indebtedness and future advances from the time this Mortgage is filed for record in the office of the Recorder of Deeds of the county where the Mortgaged Premises described herein are located. Therefore, to secure payment of the Note and all other indebtedness and obligations of Mortgagors hereunder, Mortgagors hereby grant to Mortgagee a security interest in the Mortgaged Premises and in all such deposits and agrees that, upon an Event of Default, Mortgagee shall have all of the rights and remedies of a secured party under the Illinois Uniform Commercial Code.

- Any one or more of the following shall constitute an event of default ("Event of Default") hereunder: (a) default in the payment, when due, (whether by lapse of time, acceleration or otherwise) of the principal of or interest on any Note or of any other indebtedness hereby secured; or (b) default for more than seven (7) days after written notice thereofis sent to Mortgagors in the observance or compliance with any other covenant, warranty, term or provision of this Mortgage, or of any other instrument or document securing the Note or relating thereto, including without limit, that certain Security Agreement of even date herewith between Borrower as debtor and Mortgagee as secured party (the "Security Agreement"); or (c) any representation or warranty made by any Mortgagor herein or by any Mortgagor or

Borrower in any separate assignment of leases and/or rents securing the Note or in the Security Agreement or in any other instrument or document securing the Note or relating thereto or in any statement or certificate furnished by it pursuant hereto or thereto proves to be untrue or misleading in any material respect as of the date of issuance or making thereof; or (d) the Mortgaged Premises, or any part thereof, shall be sold, transferred or conveyed, whether voluntarily or involuntarily, by operation of law or otherwise; or (e) any indebtedness secured by a lien or charge on the Mortgaged Premises or any part thereof (including, without limit, the Senior Mortgage) is not paid when due or proceedings are commenced to foreclose or otherwise realize upon any such lien or charge or to have a receiver appointed for the property subject thereto or to place the holder of such indebtedness or its representative in possession thereof; or (f) Borrower or any Mortgagor becomes insolvent or bankrupt or admits in writing its or his inability to pay its or his debts as they mature or makes an assignment for the benefit of creditors or applies for or consents to the appointment of a trustee, custodian or receiver for the major part of its or his property or such a trustee, custodian or receiver is appointed for Borrower or any Mortgagor or for the major part of the properties of any of them and is not discharged within thirty (30) days after such appointment, or bankruptcy, reorganization, arrangement, insolvency, readjustment, liquidation, dissolution or other proceedings for relief under any present or future bankruptcy laws or laws or other statute, law or regulation for the re'iei of debtors are instituted by or against Borrower or any Mortgagor, and if instituted against such party are consented to Gracquiesced in or are not dismissed within thirty (30) days after such institution, or Borrower or any Mortgagor takes any action in contemplation of or furtherance of any of the foregoing; or (g) there shall be any execution, attachment or levy on the Mortgaged Premises not stayed or released within thirty (30) days; or (h) any financial or other information submitted by Borrower or any Mortgagor to Mortgagee proves untrue in any material respect; or (i) the Mortgaged Premise's are abandoned; or (j) any Mortgagor shall die or become incompetent, or any guarantor shall terminate, revoke, repudine or disavow any of his or its obligations under the Guaranty; or (k) Borrower shall voluntarily or involuntarily dissolve; or (1) an event of default shall occur under any other mortgage or other security document securing the payment of the Note and not be cured within any applicable grace period.

When any Event of Default has occurred and is continuing (regardless of the pendency of any proceeding which 13. has or might have the effect of preventing Mortgage's from complying with the terms of this instrument and of the adequacy of the security for the Note) and in addition to st on other rights as may be available under applicable law, but subject at all times to any mandatory legal requirements: (a) Mortgagee may, by written notice to Mortgagors, declare the Note and all unpaid indebtedness of Mortgagors hereby secured, including any interest then accrued thereon, to be forthwith due and payable, whereupon the same shall become and bet orthwith due and payable, without other notice or demand of any kind; (b) Mortgagee shall, with respect to any part of the Mortgaged Premises constituting property of the type in respect of which realization on a lien or security interest grante I the ein is governed by the Illinois Uniform Commercial Code, have all the rights, options and remedies of a secured party under the Illinois Uniform Commercial Code; (c) Mortgagee may proceed to protect and enforce the rights of Mortgagee nere under (i) by any action at law, suit in equity or other appropriate proceedings, whether for the specific performance of any agreement contained herein, or for an injunction against the violation of any of the terms hereof, or in aid of the exercise of any power granted hereby or by law; or (ii) by the foreclosure of this Mortgage in any manner permitted by law; (d) Mortgagee shall, as a matter of right, without giving bond to Mortgagors or anyone claiming by, under or through them and without regard to the solvency or insolvency of Mortgagors or the then value of the Mortgaged Premises, be entired to have a receiver appointed of all or any part of the Mortgaged Premises and rents, issues and profits thereof, with such power as the court making such appointment shall confer, and Mortgagors hereby consent to the appointment of such receiver and shall not oppose any such appointment.
