In consideration of the mutual promises and agreements exchanged, the parties hereto agree as follows (notwithstanding anything to the contrary contained in the Note or Security Instrument):

- 1. As of <u>December 1, 1994</u> the amount payable under the Note and Security Instrument (the "Unpaid Principal Balance") is U.S. \$68,266,46, consisting of the amount(s) loaned to the Borrower by the Lender and any interest capitalized to date.
- 2. The Borrower promises to pay the Unpaid Principal balance, plus interest, to the order of the Lender. Beginning on <u>December 1</u>, 19.94, interest on the Unpaid Principal Balance will be reduced from a yearly rate of 10.375% to the yearly rate of 9.375% (the "rate of interest"). The Borrower promises to make monthly payments of principal and interest of U.S. \$582.08 beginning on the <u>1st</u> day of <u>January</u>, 19.95 and continuing thereafter on the same day of each succeeding month until principal and interest are paid in full.

The Borrower will make payments at <u>Citteorp Mortgage</u>, Inc., 15851 Clayton Road, Ballwin, MO 63011 or at such other place as the Lender may require.

3. The Maturity Date of the Note and Security Instrument are extended from April 1, 2021 to May 1, 2021. If on the Maturity Date, the Borrower still owes amounts under the Note and the Security Instrument, as amended by this Agreement, the Borrower will pay these amounts in full on the Maturity Date.

Except as otherwise specifically provided in this Agreement, the Note and Security Instrument will remain unchanged, and the Borrower and Lender will be bound by, and comply with, all of the terms and provisions thereof, as amended by this Agreement.
