IT IS HEREBY AGREED, by and between SUBURBAN TRUST AND SAVINGS BANK, the legal holder and owner of that certain Note dated August 24, 1990 and secured by Trust Deed of even date, recorded as Document No. 3907189 in the Recorder's Office of Cook County, Illinois, and JOSIP MALKOC, the Borrower that:

1. The maturity of the aforementioned Note and Trust Deed is modified and reduced to September 1, 1998.
2. The interest rate shall be reduced from 11.0% per annum to 8.5%.
3. The monthly payment of principal and interest is reduced to \$3,150.38 based upon a 12 year amortization.
4. Said interest rate change will be effective with the July 1, 1993 payment.

Except as hereby changed, all rights, duties, obligations and covenants contained in said Note and Trust Deed shall remain the same.
