



However, this option shall not be exercised by Lender if Borrower causes to be submitted by federal law. Lender also shall not exercise this option if: (a) intended transferee as if a new loan were being made to the transferee; and (b) Lender reasonably determines that Lender's security will not be impaired by the loan assumption and to Lender.

To the extent permitted by Applicable Law, Lender may charge a reasonable fee as a condition to Lender's consent to the loan assumption. Lender may also require the transferee to sign an assumption agreement that is acceptable to Lender and that obligates the transferee to keep all the promises and agreements made in the Note and in this Security Instrument. Borrower will continue to be obligated under the Note and this Security Instrument unless Lender releases Borrower in writing. If Lender exercises the option to require immediate payment in full, than 30 days from the date the notice of acceleration. The notice shall provide a period of not less Borrower must pay all sums secured by this Security Instrument. If Borrower fails to pay these security Instrument without further notice or demand on Borrower.
