
### AFFIDAVIT OF HEIRSHIP

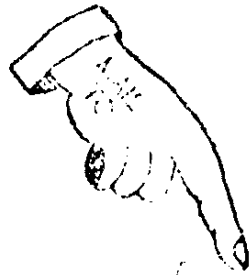
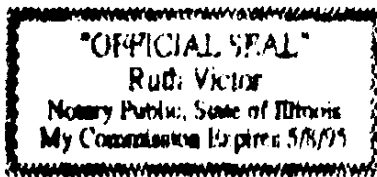
