
and commonly known as 754 Whispering Court, Unit 9-D, Palatine, Illinois.



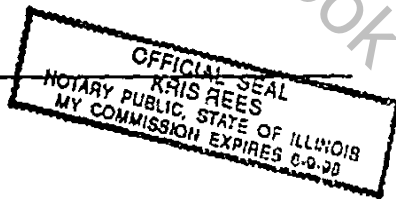
