- (K) "Electronic Funds Transfer," heart an presser of funds, other han a transletted by check, draft, or similar paper instrument, which is initiated through an electronic terminal, elephonic instrument, computer, or magnetic tape so as to order, instruct, or authorize a financial institution to debit or credit an account. 2. Application of Payments of Profeeds. Except as otherwised scribed in this Section 2, at payments accepted and applied by Lender shall be applied in the following order of priority! (a) intenst due under the Note; (b) principal due under the Note; (c) amounts due under Section 3. Such payments shall be applied to the each Periodic Payment in the order in which it became due. Any remaining amounts when the profession of t shall be applied first to late charges, second to any other amounts due under this Security Instrument, and then to reduce the principal balance of the Note.

If Lender receives a payment from Borrower for a delinquent Periodic Payment which includes a sufficient amount to pay any late Charge due, the payment may be applied to the delinquent payment and the late charge. If more than one Periodic Payment is outstanding, Lender may apply any payment received from Borrower to the repayment of the Periodic Payments if, and to the extent that, each payment can be paid in full.
