That all materials and labor (umished by Claimant were accepted for the Premises by Armirae and the Trust; were used on the Premises; are an integral part thereof; and constitute a permanent and valuable improvement to the Premises, enhancing the value of the Premises to the extent of or in excess of \$5,500.00.

The Trust is entitled to credits on account in the amount of \$3,000.00 leaving due, unpaid and owing to Claimant the amount of \$2,5000.00 of which, with imprest, the Claimant claims a lien on said land and improvements.
