- 12. DEFAULT. Mortgagor will be in default if any party obligated on the Secured Del/t fails to make payment when due. - 13. REMEDIES ON DEFAULT. - 14. EXPENSES; ADVANCES ON COVENANTS; ATTORNEYS' FEES; COLLECTION COSTS.
