#### MEMORANDUM OF AGREEMENT

THIS MEMORANDUM OF AGREEMENT ("Memorandum") is executed as of the day of June, 2003, by and bet veen WILLIAM R. ROSE, as Trustee under the provisions of the Amendment and Restatement of the William R. Rose Declaration of Trust dated June 10, 1987 ("Owners") and THE VILLAGE OF SOUTH BARRINGTON, an Illinois municipal corporation ("Village").

- 1. The Village has approved the first Plat of Subdivision for the Glen of South Barrington which includes the subdivided lot ("Lot 125") more fully described in **Exhibit A** attached hereto subject to the conditions expressed in this Memorandum ("Conditions").
  - 2. The conditions which relate to Lot 123 are:
    - Owner shall obtain a letter of map revision from the United States Army Corps of Engineers in response to the Owner's application therefore, a copy of which has been furnished to and kept on file with the Village.
    - Compliance with Village codes regarding the minimum area (51,000 square feet) above the 100 year flood crest elevation and other matters affecting the issuance of a building permit for a single family detached residence under the zoning district applicable to Lot 123.
  - 3. Until the Owner has complied with the Conditions:
    - Lot 123 will not be conveyed to a third party purchaser;
    - no improvements, other than landscaping, will be installed or constructed on Lot 123.
