1. ASSIGNMENT. 3. COVENANTS OF GRANTOR. Grantor covenants and Carast that Grantor will:

Grantor has not accepted, and will not accept, rent in excess of one month in advar se uniter any of the Leases.

Grantor has the power and authority to execute this Assignment.

- ETITE SERVICES # 5. GRANTOR MAY RECEIVE RENTS. As long as there is no default under the Note described above, the Mortgage securing the Note, this Agreement or any other present or future obligation of Borrower or Grantor to Lender ("Obligations"), Grantor may a xilent all rents and profits from the Leases when due and may use such proceeds in Grantor's business operations. However, Lender may at any time require Cruntor to deposit all rents and profits into an account maintained by Grantor or Lender at Lender's institution.
 - 6. DEFAULT AND REMEDIES. Upon default in the payment of, or in the performance of, any of the Obligation. Lender may at its option take possession of the real property and the improvements and have, hold, manage, lease and operate the Premises on take and for a period of time that Lender deems proper. Lender may proceed to collect and receive all rents, income and profits from the Premises, and it ander shall have full power to periodically make alterations, renovations, repairs or replacements to the Premises as Lender may deem proper.  - 7. POWER OF ATTORNEY. Grantor irrevocably authorizes Lender as Grantor's attorney-in-fact coupled with an interest, at Lender's option, upon taking possession of the real property and improvements under this Assignment, to lease or re-lease the Premises or any part thereof, to cancel and modify Leases, evict tenants, bring or defend any suits in connection with the possession of the Premises in the name of either party, make repairs as Lender deems appropriate and perform such other acts in connection with the management and operation of the real property and improvements as Lender may deem proper.  - 8. BENEFICIAL INTEREST. Lender shall not be obligated to perform or discharge any obligation, duty or liability under the Leases by reason of this Assignment. Grantor hereby agrees to indemnify Lender and to hold Lender harmless from any and all liability, loss or damage which Lender may incur under the Leases by reason of this Assignment and from any and all claims and demands whatsoever which may be asserted against Lender by reason of any alleged obligations or undertakings on Lender's part to perform or discharge any of the terms or agreements contained in the Leases.
