EXTENSION AGREEMENT

This Agreement entered into this 20th day of October, 1994, by and between Harria Trust and Bavings Bank, a corporation duly organized and existing under and by virtue of the laws of the State of Illinois, not paraonally but as Trustoo under the provisions of a dead or deeds in trust duly recorded and delivered to said company in pursuance of a Trust Agreement dated June 24, 1982 and known as Trust No. 41844, as maker of: a Mortgatge Installment Note dated October 2, 1989, in the principal amount of \$340,000.00 (the "Note"), and by and between Harris Trust and Savings Bank, a corporation duly organized and existing under and by virtue of the laws of the State of illinate, not personally but as Trustee under the provisions of a dead or deeds in trust duly recorded and delivered to said company in pursuance of a Trust Agreement dated June 24, 1982, and known as Trust No. 41844, as maker of: a Mortgage dated October 2, 1989, securing the Note and recorded with the Recorder of Deads of Cook County on October 25, 1989, as Document No. 89507151 (the "Morchaga"); an Assignment of Routs dated October 2, 1989, securing the Note and recorded with the Recorder of Doedn of Cook County on October 25, 1989, an Openant No. 89507152 (the "Anaignment of Renta") and Bank of Lincolnwood a owner and holder of the Note and Mortgage, and Analgoment of Ronte.
