Both checks were not honored by the bank upon presentment due to no surficient funds (NSF).

The amount of Two Thousand Four Hundred Fifty and 00/100 dollars (\$2,450.00) remains unpaid and owing.

On February 27, 2004, a subcontractor's 90 days notice of lien was served on Owner and a copy on the general contractor, Rapity Incorporated.

Vazquez claim this amount with interest and claims a lien upon the land and improvements pursuant to 770 ILCS 60/.01 et seq. as amended in order to secure the stans now due.
