SECOND AMENDMENT TO THE DECLARATION OF CONDOMINIUM PURSUANT TO THE CONDOMINIUM PROPERTY ACT FOR THE ALEXANDRIAN CONDOMINIUM

This document is recorded for the purpose of amending the Declaration of Condominium pursuant to the Condominium Property Act for the Alexandrian Condominiums, an Illinois Not-for-Profit Corporation, which was recorded as Document No. 0010561202 in the Office of the Recorder of Deeds of Cook County, Illinois.

This Amendment is adopted pursuant to the provisions of paragraph 17 of the aforesaid Declaration and Section 26 of the Phinois Condominium Property Act. 765 ILCS 605/26.

WHEREAS, this corporation and its Board of Directors are responsible for managing certain real estate in the County of Cook, State of Illinois, which real property is subject to the provisions of the Declaration of Condominium pursuant to the Condominium Property Act for the Alexandrian Condominiums, an Illinois Not-for-Profit Corporation, which was recorded as Document No.0010561202 (hereinafter "Declaration"); and

WHEREAS, this Declaration Amendment has been executed by the owners affected by the right and use of the transferred limited common elements, all in compliance with the Declaration and the Illinois Condominium Property Act.

NOW THEREFORE, the Declaration is hereby amended in accordance with the text which follows:

- 1. Storage Locker Number 7, located at the property commonly known as 7213 W. Division Street, River Forest, IL 60305, which is part of the limited common elements, pursuant to Exhibit B of the Association's declaration, is hereby transferred from Preston Adams to Rosemary Camilleri.
- 2. The percentage of ownership assigned to Storage Locker Number 7, as stated in Exhibit B of the declaration shall remain the same.
- 3. Rosemary Camilleri shall be responsible for the maintenance and expenses related to this portion of the limited common elements, Storage Locker Number 7.
- 4. This Amendment was delivered to the Board for the Association on Feb. 28, 2004, via hand delivery, by Rosemany Camilleri.
- 5. The only parties affected by the transfer of the limited common elements is Preston Adams and Rosemary Camilleri.
