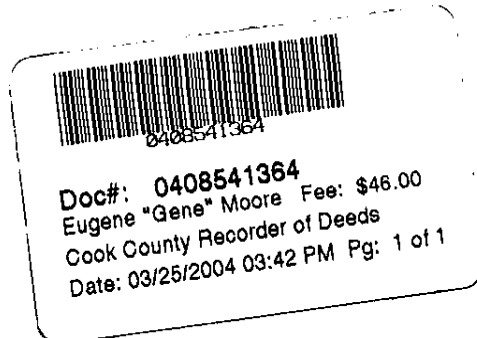


LIMITED POWER OF ATTORNEY

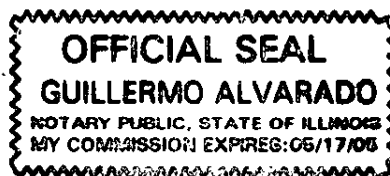
