This Subordination Agreement made in the Village of Wilmette, State of Illinois, this 12<sup>th</sup> day of March, 2004, by the EDENS BANK, a banking association organized and existing under and by virtue of the laws of the United States of America, and doing business and having its principal office in the Village of Wilmette, County of Cook, and State of Illinois ("Bank");

WHEREAS, Jong W. Suh and In Soon Suh, Husband and wife, as tenants by the entirety by their Mortgage dated the 30<sup>th</sup> day of August, 2000 and recorded in the office of the Recorder of Deeds of COOK County, Illinois on the 8<sup>th</sup> day of September, 2000, as Document No. 00695855 did convey unto EDENS BANK an interest in certain premises in COOK County, Illinois, described as follows:

NOW THEREFORE, in consideration of the premises and of the sum of ten dollars in hand paid, and the said EDENS BANK does hereby covenant and agree with the said, HOME COMINGS FINANCIAL NETWORK its Successors and/or Assigns, for the use and benefit of the legal holder of the Note secured by said Mortgage securing the same shall be and remain at all times a second lien of the Mortgage to said HOME COMINGS FINANCIAL NETWORK, Its Successors and/or Assigns as foresaid for all advances made or to be made on the notes secured by said last named Mortgage and for all other purposes specified therein.





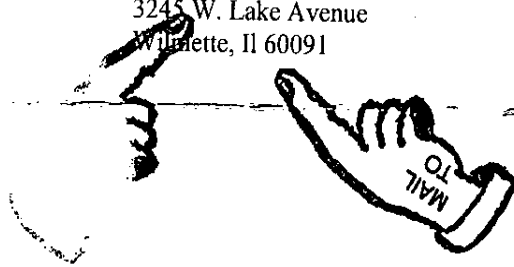
