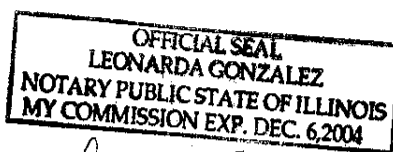
## LOAN AGREEMENT
