



If substantially equivalent Mortgage Insurance coverage is not available, Borrower shall continue to pay to Lender the amount of the separately designated payments that were due when the insurance coverage ceased to be in effect. Lender will accept, use and retain these payments as a non-refundable lost reserve in lieu of Mortgage Insurance. that are satisfactory to the mortgage insurer and the other party (or parties) to these agreements. 




