- (1) (a) <u>Land</u>. The real property described in Exhibit A attached hereto and made a part hereof (the "Land");
- that certain Ground Lease between FELCOR LODGING LIMITED PARTNERSHIP, as owner ("FLLP"), and FELCOR/CMB DEERFIELD HOTEL, L.L.C., as tenant ("Borrower"), dated Apri' 30, 2000 (the "Ground Lease"), including, all assignments, modifications, extensions and renewals of the Ground Lease and all credits, deposits, options, privileges and rights of Borrower as tenant under the Ground Lease, including, but not limited to, rights of first refusal, if any, and the right, if any, to renew or extend the Ground Lease for a succeeding term or terms, and also including all the right, title, claim or demand whatsoever of Borrower either in law or in equity, in possession or expectancy, of, in and to Secured Party's right, as tenant under the Ground Lease, to elect under Section 365(h)(1) of the Bankruptcy Code, Title 11 U.S.C.A. §101 et seq. (the "Bankruptcy Code") to terminate or treat the Ground Lease as terminated in the event (i) of the bankruptcy, reorganization or insolvency of FLLP, and (ii) the rejection of the Ground Lease by FLLP, as debtor in possession, or by a trustee for FLLP, pursuant to Section 365 of the Bankruptcy Code;
- by DJONT/CMB DEERFIELD LEASING, L.L.C. the "Operating Tenant") and created pursuant to that certain Operating Lease between FILP, as sub-lessor, and DJONT LEASING, L.L.C., as sub-lessee, dated June 20, 1996, as amended (the "Operating Lease"), including, all assignments, modifications, extensions and renewals of the Operating Lease and all credits, deposits, options, privileges and rights of Operating Tenant as tenant under the Operating Lease, including, but not limited to, rights of first refusal, if any, and the right, if any, to renew or extend the Operating Lease for a succeeding term or terms, and also including all the right, title, claim or demand whatsoever of Operating Tenant either in law or in equity, in possession or expectancy, of, in and to Secured Party's right, as tenant under the Operating Lease, to elect under Section 365(h)(1) of the Bankruptcy Code to terminate or treat the Operating Lease as terminated in the event (i) of the bankruptcy, reorganization or insolvency of the Borrower, and (ii) the rejection of the Operating Lease by the Borrower, as debtor in possession, or by a trustee for the Borrower, pursuant to Section 365 of the Bankruptcy Code;
- (2) Additional Land. All additional lands, estates and development rights hereafter acquired by Debtor for use in connection with the Land and the development of the Land and all additional lands and estates therein which may, from time to time, by supplemental mortgage or otherwise be expressly made subject to the lien of the Security Instrument (hereinafter defined);
