THIS FLEXEQUITY MORTGAGE is made this 16th day of April 2004 by and between
John F. Ostry and Christine A. Ostry, Husband and Wife

(herein "Borrower") and GLENVIEW STATE BANK, an Illinois Corporation, whose address is 800Waukegan Road, Glenview, Illinois 60025 (herein "Lender").

Whereas, Borrower is indebted to Lender under that certain FlexEquity Account Promissory Note dated April 16, 2004 (herein "Note") with a credit limit of Two Hundred Twenty Five Thousand Dollars and no / 100 dollars (\$ 225,000.00) (a minimum amount of \$10,000.00) of which an initial advance of XXXXXXXXXXXXXXXXXXXXXXXXXX has been made and against which Borrower may draw and Lender is obligated to make advances from time to time to the full amount thereof. Repayments of sums advanced from time to time will replenish the credit limit pro tanto so that the total amount that may be lent under the Note may exceed the credit limit thereof but not at any one time. The Note provides for monthly installments of interest or, if Borrower has elected to take any advance as a term loan, of principal and interest, at the rates set forth in the Note, with the principal balance of the indebtedness, if not sooner paid or required to be paid, due and payable five (5) years from the date hereof.

Borrower, in consideration of the indebtedness herein recited, does hereby mortgage, grant, warrant and convey (unless Borrower is a Trust, in which event Borrower does hereby mortgage, grant, quitclaim and convey) unto Lender and its successors and assigns, the following described property located in the County of , State of Illinois:

COVENANTS. Borrower and Lender covenant and agree as follows:

1. PAYMENT AND COMPLIANCE WITH NOTE; APPLICATION OF PAYMENTS. Borrower shall promptly pay when due the principal and interest on the indebtedness evidenced by the Note together with any late charges or other charges imposed under the Note, and the principal and interest on any Future Advances as defined in Paragraph 27 below) secured by this Mortgage. Unless applicable law requires otherwise, all payments received under the Note and this Mortgage shall be applied by Lender first in Payment of any additional sums owing to Lender pursuant to the provisions of the Credit Documents, whether as advances, attorney's fees (to the extent permitted by law), delinquencies, costs and expenses of exercising rights and remedies granted under the Credit Documents; second, to the payment of any sums due under Paragraph 2 hereof; third, to the payment of interest on the Note; fourth, to the payment of principal of the Note; and then to interest and principal on any Future Advances.

Covenants. Borrower and Lender covenant and agree as follows:

THIS MORTGAGE IS GIVEN TO SECURE: (i) the repayment of all other sums, with interest thereon, advanced in a coordinate manner to protect the security of this mortgage; and (ii) the title to the property as held by a Trust, in the FlexEquity Security Agreement (the "Security Agreement") of even date herewith. The Note, the Security Agreement and all instruments now or hereafter given to evidence or secure the indebtedness evidenced by the Note are collectively referred to herein as the "Credit Documents". The Credit Documents constitute and this Mortgage permits and secures, future advances.

Borrower acknowledges that the Note calls for a variable interest rate, and that the Lender may, prior to the expiration of the term of the Note, cancel future advances thereunder, reduce the amount of credit available, and/or require repayment of the outstanding balance under the Note.

TO HAVE AND TO HOLD THE PROPERTY SUBJECT TO THE LEASEHOLD ESTATE FOR THE TERM AND IN THE MANNER PROVIDED IN THE LEASE AGREEMENT.

TOGETHER WITH all improvements now or hereafter erected on the property, and all easements, rights, rents), royalties mineral, oil and gas rights and royalties given herein to Lender to collect and apply such property, and rents (subject however to the rights and authorities given herein to Lender to collect and apply such rentals), roylalties mineral, oil and gas rights and royalties given herein to Lender to collect and apply such condominiums now or hereafter attached to the property, all of which, including replacement units and additions thereto, shall be deemed to be and remain a part of the property covered by this mortgage, and of the foregoing, together with said property (or the leasehold estate if this Mortgage is on a leasehold) are hereinafter referred to as the "Property"; as to any property which does not constitute a fixture (as such term is defined in the Uniform Commercial Code), this Mortgage is deemed to be, as well, a Security Agreement under the UCC for the purpose of creating a security interest in such property, which Borrower hereby grants to Lender as Secured Party (as such term is defined in the UCC); and notwithstanding anything to the contrary herein, the Property shall include all of Borrower's right, title, and interest in and to the real property described above whether such right, title, and interest acquired before or after execution of this Mortgage.

Specificaly, and without limitation of the foregoing, if this Mortgage is given with respect to a leasehold estate held by Borrower, and subsequently acquires a fee interest in the real property, the lien of this Mortgage shall attach to and include the fee interest acquired by Borrower.

insurance, plus one-twelfth of yearly premium installments for mortgage insurance, if any, all as reasonably estimated initially and from time to time by Lender on the basis of assessments and bills and reasonable estimates thereof.

The funds shall be held in an institution the deposits or accounts of which are insured or guaranteed by a Federal or State Agency (including Lender if Lender is such an institution). Lender shall apply the Funds to pay said taxes, assessments, insurance premiums and ground rents. Lender may not charge for so holding and applying the Funds, analyzing said account or verifying and compiling said assessments and bills, unless Lender pays Borrower interest on the Funds and applicable law permits Lender to make such a charge. Borrower and Lender may agree in writing at the time of execution of the language that interest on the Funds shall be paid to Borrower, and unless such agreement be made or applicable law requires such interest to be paid, Lender shall not be required to pay Borrower any interest or earnings on the Funds. Lender shall give to Borrower, without charge, an annual accounting of the Funds showing credits and debits to the Funds and the purpose for which each debit to the Funds was made. The Funds, if any, are pledged as additional security for the sums secured by this Mortgage, and are held by Lender as a creditor and not as a trustee.

If the amount of the Funds held by Lender, together with the future monthly installments of Funds payable prior to the due dates of taxes, assessments, insurance premiums and ground rents, shall exceed the amount required to pay said taxes, assessments, insurance premiums and ground rents as they fall due, such excess shall be, at Borrower's option, either promptly repaid to Borrower or credited to Borrower on subsequent monthly installments of Funds. If the amount of Funds held by Lender shall not be sufficient to pay taxes, assessments, insurance premiums and ground rents as they fall due, Borrower shall pay to Lender any amount necessary to make up the deficiency within thirty (30) days from the date notice is mailed by Lender to Borrower requesting payment thereof.

Neither Lender nor any institution designated by Lender to hold the Funds shall be liable for any failure to make the payments of insurance premiums, taxes or ground rents unless Borrower, while not in default hereunder, shall have requested Lender or such institution to make application of the Funds to the payment of the applicable insurance premiums, taxes or ground rents, accompanied by the bills for such insurance premiums, taxes or ground rents. Notwithstanding the foregoing Lender may, at its option, make or cause such institution to make any such application of the Funds without any direction or request to do so by Borrower.

Upon payment in full of all sums secured by this Mortgage, Lender shall promptly refund to Borrower any funds held by Lender. If under Paragraph 17 hereof the Property is sold or the Property is otherwise acquired by Lender, Lender shall apply, no later than immediately prior to the sale of the Property or its acquisition by Lender, any Funds held by Lender at the time of application as a credit against the sums secured by this Mortgage.

3. PRIOR ENCUMBRANCE; CHARGES; LIENS. Borrower shall fully and timely perform all of Borrower's obligations under any mortgage, deed of trust or other security agreement with a lien which has or appears to have any priority over this Mortgage, including Borrower's covenants to make any payments when due. A default under any prior mortgage or deed of trust or other security agreement with a lien which has or appears to have any priority over this Mortgage may at the option of Lender be declared and deemed to be a default under this Mortgage but only if such default adversely affect Lender's security for the note of any rights of Lender in the security. Borrower shall pay all taxes, assessments and other charges, fines and impositions attributable to the Property which may attain a priority over this Mortgage, and leasehold payments or ground rents, if any, in the manner provided under Paragraph 2 hereof or, if not paid in such manner, by Borrower making payment, when due, directly to the payee thereof. Borrower shall promptly furnish to Lender all notices of amounts due under this paragraph, and in the event Borrower shall make payment directly, Borrower shall promptly furnish to Lender receipts evidencing such payments. Borrower shall promptly discharge any lien which may attain priority over this Mortgage (other than any prior first mortgage or deed of trust); provided, that Borrower shall not be required to discharge any such lien so long as Borrower shall agree in writing to the payment of the obligation secured by such lien in a manner acceptable to Lender or shall in good faith contest such lien by, or defend enforcement of such lien in, legal proceedings which operate to prevent the enforcement of the lien or forfeiture of the Property or any part thereof.

4. HAZARD INSURANCE. Borrower shall, at Borrower's cost keep the improvements now existing or hereafter erected on the Property insured against loss by fires, hazards included within the term "extended coverage and such other hazards (collectively agreed to as "Hazards" as Lender may require. Borrower shall maintain Hazard insurance for the entire term of the Note or such other periods as Lender may require and in an amount equal to the lesser of (a) the maximum insurable value of the Property or (b) the amount of the line of credit secured by this Mortgage plus the outstanding amount of any obligations secured in priority over this Mortgage, but in no event shall such amounts be less than the amount necessary to satisfy the co-insurance requirement contained in the insurance policy.

6. **PROTECTOR OF LENDER'S SECURITY.** If Borrower fails to perform the covenants and agreements contained in this Mortgage or in the Credit Documents, or if any action or proceeding is commenced which affects Lender's interest in the Property or the rights of Lender hereunder, including but not limited to eminent domain, insolvency, code enforcement or arrangements involving a bankruptcy or decedent, then Lender, without demand upon Borrower but upon notice to Borrower pursuant to Paragraph 11 hereof, may, without releasing, code enforcement or proceedings of proceedings involving a bankruptcy or decedent, defend the action or proceeding, make such appearances, defend the action or proceedings, disburse such sums, including reasonable attorney's fees, and take such action as Lender deems necessary to protect the security of this Mortgage. If Lender has required mortgage insurance in making the loan secured by this Mortgage, Borrower shall pay the premiums required to maintain such insurance in effect until such time as the requirement for such insurance terminates in accordance with Borrower's and Lender's written agreement of applicable law.

PRESERVATION AND MAINTENANCE OF PROPERTY; LEASEHOLDS; CONDOMINIUMS; PLANNED UNIT DEVELOPMENTS. Borrower shall use, improve and maintain the Property in compliance with applicable laws, statutes, ordinances, decrees or regulations, shall keep the Property in good condition and repair including the repair or restoration of any damage or destruction, shall not commit or permit waste or permit impairment of deterioration of the Property, and shall fully and promptly comply with the provisions of any lease if this Mortgage is on a leasehold. If this Mortgage is on a unit in a condominium or a planned unit development, Borrower shall promptly perform all of Borrower's obligations under the declaration or covenants relating to governing the condominium or planned unit development, the by-laws and regulations of the condominium or planned unit development or planned unit development as if they were a part hereof.

CONDOMINIUM OR PLANNED UNIT DEVELOPMENT; BORROWER'S LIABILITY FOR DAMAGE TO OTHER UNITS. This Mortgage, the covenants and agreements of such rider shall be incorporated into and shall amend and supplement this Mortgage, the covenants and agreements of such rider shall be incorporated into and shall amend and supplement the covenants of the condominium or planned unit development, and constitute documents all as may be amended from time to time. If a condominium unit development rider is executed by Borrower and recorded together with this Mortgage, the condominium unit development rider shall be incorporated into and shall amend and supplement the covenants of the condominium or planned unit development, the by-laws and regulations of the condominium or planned unit development as if they were a part hereof.

Unless Lender and Borrower otherwise agree in writing, any such application or proceeds to principal shall not extend or postpone the due date of the installments referred to in Paragraph 1 and 2 hereof or change the amount of such installments.

If under Paragraph 17 hereof the Property is acquired by Lender, title and interest of Borrower in and to any insurance policies and in and to the proceeds thereof resulting from damage to the Property prior to such sale or acquisition shall become the Property of Lender to the extent of the sums secured by this Mortgage immediately prior to such sale or acquisition.

If the Property is abandoned by Borrower or if Borrower fails to respond to Lender in writing within thirty (30) calendar days from the date notice is mailed by Lender to Borrower that the insurance carrier offers to settle a claim for insurance benefits, Lender is irrevocably authorized to sue the claim and to collect and apply the insurance proceeds at Lender's sole option either to restoration or repair the Property or to the sums secured by this Mortgage.

Subject to the rights and terms of any mortgagee, deed of trust or other security agreement, subject to have a priority over this Mortgagee and unless Borrower and Lender otherwise agree in writing insurance premiums to have a priority over this Mortgagee and unless Borrower and Lender otherwise agree in writing insurance premiums shall be applied to restoration or repair of the Property damaged, provided such restoration or repair is economically feasible and the security of this Mortgage is not thereby impaired. If such restoration or repair is not economically feasible or if the security of this Mortgage is not otherwise impaired, the insurance proceeds shall be applied to repair of the Property damaged, provided such restoration or repair is economically feasible and the security of this Mortgage is not thereby impaired. Such application shall not cure or waive any default under this Mortgage or invalidate any act done pursuant to such notice.

In the event of loss, Borrower shall give prompt notice to the insurance carrier and Lender may make proof of loss if not made promptly by Borrower.

The insurance carrier providing the insurance shall be chosen by Borrower subject to approval by Lender; provided, that such approval shall not be reasonably withheld. All insurance policies and renewals thereof shall be in a form acceptable to Lender. Lender shall have the right to hold the policies and renewals thereof, subject to the terms of any mortgage, deed of trust or other security agreement with which has or appears to have any priority over this Mortgage. All premiums on insurance policies shall be paid in the manner provided in Paragraph 2 hereof, if not paid in such manner, by Borrower making payment, when due, directly to the insurance carrier. If Borrower makes the premium payment directly, Borrower shall promptly furnish to Lender all renewal notices and, if requested by Lender, all receipts of paid premiums. If policies and renewals are held by any other person, Borrower shall supply copies of such to Lender within ten (10) calendar days after issuance.

Any amounts disbursed by Lender pursuant to this Paragraph 6, with interest thereon at the rate from time to time in effect under the Note for revolving credit advances, shall become additional indebtedness of Borrower secured by this Mortgage. Unless Borrower and Lender agree, in writing, to other terms of payment such amounts shall be payable upon notice from Lender to Borrower requesting payment therefor and if such are not paid within the time period set forth in such notice, such amounts may be charged by Lender as a draw on the Note. Nothing contained in this Paragraph 6 shall require Lender to incur any expense or take any action hereunder and any action taken shall not release Borrower from any obligation in this Mortgage.

7. INSPECTION. Lender may make or cause to be made reasonable entries upon and inspections of the Property, provided that, except in an emergency, Lender shall give Borrower notice prior to any such inspection specifying reasonable cause therefor related to Lender's interest in the Property.

8. CONDEMNATION. The proceeds of any award or claim for damages, direct or consequential, in connection with any condemnation or other taking of the Property, or part thereof, or for conveyance in lieu of condemnation, are hereby assigned and shall be paid to Lender subject to the terms of any mortgage, deed of trust or other security agreement with a lien which has priority over this Mortgage. Borrower agrees to execute such further documents as may be required by the condemnation authority, to effectuate this paragraph. In the event of a total taking of the Property, the proceeds shall be applied to the sums secured by this Mortgage, with the excess, if any, paid to Borrower. In the event of a partial taking of the Property, unless Borrower and Lender otherwise agree in writing, there shall be applied to the sums secured by this Mortgage such proportion of the proceeds as is equal to that proportion which the amount of the sums secured by this Mortgage immediately prior to the date of taking bears to the fair market value of the Property immediately prior to the date of taking, with the balance of the proceeds paid to Borrower.

If the Property is abandoned by Borrower or if, after notice by Lender to Borrower that the condemnor offers to make an award or settle a claim for damages, Borrower fails to respond to Lender within thirty (30) days after the date such notice is mailed, Lender is authorized to collect and apply the proceeds, at Lender's option, either to restoration or repair of the Property or to the sums secured by this Mortgage.

Unless Lender and Borrower otherwise agree in writing, any such application of proceeds to principal shall not extend or postpone the due date of the installments referred to in Paragraph 1 and 2 hereof or change the amount of such installments.

9. BORROWER NOT RELEASED; FORBEARANCE BY LENDER NOT A WAIVER. Extension of the time for payment, acceptance by Lender of payments other than according to the terms of the Note, modification in payment terms of the sums secured by this Mortgage granted by Lender to any successor in interest of Borrower, or the waiver or failure to exercise any right granted herein or under the Credit Documents shall not operate to release in any manner the liability of the original Borrower, Borrower's successors in interest, or any guarantor or surety thereof, Lender shall not be required to commence proceedings against such successor or refuse to extend time for payment or otherwise modify payment terms of the sums secured by this Mortgage by reason of any demand made by the original Borrower and Borrower's successors in interest. Lender shall not be deemed, by any act of omission or commission, to have waived any of its rights or remedies hereunder unless such waiver is in writing and signed by Lender. Any such waiver shall apply only to the extent specifically set forth in the writing. A waiver as to one event shall not be construed as continuing or as a waiver as to any other event. The procurement of insurance or the payment of taxes, other liens or charges by Lender shall not be a waiver of Lender's right as otherwise provided in this Mortgage to accelerate the maturity of the indebtedness secured by this Mortgage in the event of Borrower's default under this Mortgage or the other Credit Documents.

10. SUCCESSORS AND ASSIGNS BOUND; JOINT AND SEVERAL LIABILITY; CO-SIGNERS; CAPTIONS. As used herein, the terms "Borrower" and "Lender" shall include their respective heirs, devisees, endorsees, guarantors, sureties, endorsers, legal representatives, successors, assigns and subsequent holders of the Note. All of the terms, covenants, conditions, and agreements set forth herein shall be binding upon and terms to the benefit of such parties except that no right shall inure to any successor of Borrower unless consumed to by Lender as herein provided. Borrower hereby acknowledges that Lender may freely assign or transfer all or any part of Lender's rights hereunder. If one or more person or entity signs this Mortgage, each of them is jointly and severally obligated hereunder. Any

B. Set forth below is a list of events which, upon the lapse of the applicable grace period, if any, shall trigger an Event of Default:

- (1) Borrower's failure to pay when due any amounts due under the Credit Documents (30 day grace period);
- (2) Lender's receipt of actual knowledge of any fraud or material misrepresentation by Borrower in connection with the line of credit, whether committed in or omitted from Borrower's credit application or communication during the term of the Note (no grace period);
- (3) Borrower's death or change in marital status and the transfer of Borrower's interest in the Property of the Collateral (as such term is defined in the Security Agreement) to someone who is a signer of all the Credit Documents, if any, and, as a result thereof, Lender's sale of transfers of, or promises to sell or transfer, all or any part of the Property or any interest therein, of any interest in the Collateral, whether voluntary or involuntary, without Lender's prior written consent (no grace period);

A. An Event of Default will occur if Lender fails to provide notice of the breach of Borrower's promises under any of the Credit Documents and upon Borrower's failure to cure such breach and to provide Lender with evidence reasonably satisfactory to it of such cure, within the applicable grace period, if any. In each case, the grace period begins to run on the day after notice is given, and expires at 11:59 p.m., Central time, on the last day of the period. All grace periods are expressed in calendar days, not business days. If there is no grace period applicable to a particular type of default, the Event of Default will be complete upon the giving of the notice. Such notice shall be given to Borrower in accordance with Paragraph 11 hereof and shall contain the following information: (1) the nature of Borrower's breach; (2) the applicable grace period, if any, during which such breach must be cured; and (3) whether failure to cure such breach within the specified grace period, if any, will result in acceleration of the sums secured by this Mortgage and the potential foreclosure of this Mortgage. The notice shall further inform Borrower of the right, if any under applicable law, to remit late the revolving line of credit under this Mortgage after acceleration.

14. REMEDIES CUMULATIVE. Lenender may exercise all of the rights and remedies provided in this Mortgage and in the Credit Documents, or which may be available to Lenender by law, and all such rights and remedies shall be cumulative and concurrent, and may be pursued singly, successively or together, at Lenender's sole discretion, and may be exercised as often as occasion therefor shall occur.

13. BORROWER'S COPY. Borrower shall be furnished a controlled copy of the Note and of this Mortgage at the time of execution or after recordation hereof.

12. GOVERNMENT LAW; SEVERABILITY. This Mortgage shall be governed by the laws of the State of Illinois, which laws shall also govern and control the construction, enforceability and interpretation of this Mortgage. Every provision hereof is intended to be severable. In any clause, phrase, provision or portion of this Mortgage or the application thereof is determined by a court of competent jurisdiction to be invalid or unenforceable under applicable law, the remaining clauses, phrases, provisions and portions of this Mortgage shall not be affected or impeded thereby, but each such clause, phrase, provision and portion shall be valid and enforceable to the fullest extent permitted by law.

Except for any notice required under applicable law to be given in another manner: (a) any notice to Borrower provided for in this Mortgage shall be given by hand delivery if so requested; (b) any registered or certified mail addressed to, Borrower at the Property Address or at such other address as Borrower may designate by written notice to Lender as provided herein; and (c) any notice to Lender shall be given by registered or certified mail to Lender at 800 Waukegan Road, Glenview Illinois 60025 or to such other address as Lender may designate by written notice to Lender as provided herein; and (d) any notice to Lender shall be given by registered or certified mail addressed to, Borrower applicable law to be given in another manner: (a) any notice to Borrower provided for in this Mortgage shall be given by hand delivery if so requested; (b) any notice to Borrower as provided herein. Any notice provided for in this Mortgage shall be deemed to designate to Borrower as provided herein. the amendment or termination of any ground leases affecting the Property and, as a result thereof, Lender's security for the Note or any rights of Lender in the security are adversely affected; (6) Borrower files for bankruptcy, or bankruptcy proceedings are instituted against Borrower and not dismissed within sixty (60) calendar days, under any provisions of any state or federal bankruptcy law in effect at the time of filing and, as a result thereof, Lender's security for the Note or any rights of Lender in the security are adversely affected (no grace period); (7) Borrower makes an assignment for the benefit of Borrower's creditors, becomes insolvent or becomes unable to meet Borrower's obligations generally as they become due and, as a result thereof, Lender's security for the Note and rights of Lender in the security are adversely affected (no grace period); (8) Borrower further encumbers the Property or Collateral, if any, or suffers a lien, claim of lien or encumbrance against the Property or the Collateral, if any and, as a result thereof Lender's security for the Note or any rights of Lender in the security are adversely affected (30 day grace period in which to remove the lien, claim of lien or encumbrance); (9) Borrower is in default or an action is filed alleging a default under any credit instrument or mortgage evidencing or securing an obligation of Borrower with priority in right of payment over the line of credit described in the Credit Documents or whose lien has or appears to have any priority over the lien created by the Mortgage or the security interest created by the Security Agreement or any of Borrower's other creditors attempts to (or actually does) seize or obtain a writ of attachment against the Property or the Collateral, if any and, as a result thereof, Lender's security for the Note or any rights of Lender in the security are adversely affected (no grace period); (10) Borrower fails to keep any other covenant contained in any of the Credit Documents not otherwise specified in Paragraph 15 (ten (10) day grace period, unless the failure is by its nature not curable, in which case no grace period or, if another grace period is specified in the Credit Documents, that grace period will prevail); or (11) any action or inaction by Borrower which adversely affects Lender's security for this Note or any right of Lender in such security (no grace period).

16. TRANSFER OF PROPERTY. Upon the occurrence of an Event of Default as specified in Paragraph 15.B(4) above. Lender shall be entitled to immediately accelerate the amounts due under the Note and declare all indebtedness secured by this Mortgage to be immediately due and payable. Failure to pay such indebtedness within thirty (30) days after notice to Borrower of such acceleration shall constitute an Event of Default. Any use or attempted use by Borrower of the revolving line of credit evidenced by the Note after such an Event of Default shall constitute a separate Event of Default.

As an alternative to declaring all sums secured by this Mortgage to be immediately due and payable, Lender may waive its option to accelerate and agree in writing, prior to close of the sale or transfer to the transferee's assumption of the outstanding obligation under the Note, on terms satisfactory to Lender, subject to Lender's right, described in Paragraph 6.D of the Note, to freeze or reduce the line of credit. Lender's acceptance of the transferee's assumption of the obligation under Note shall not release Borrower from any of obligations under the Note and the Credit Document, and Borrower shall assume the status of the guarantor of the Note until paid in full. Borrower understands that Lender will not permit the assumption of the outstanding balance under the Note in any event and will declare the entire outstanding principal balance plus accrued interest and other charges due to be immediately due and payable (see Paragraph 17 hereof), unless (i) Borrower has submitted to Lender a written acknowledgement from the transferee that the transferee has received (a) a copy of each of the Credit Documents and (b) notice of the amount of Borrower's outstanding principal balance on the line of credit; (ii) Borrower has submitted to Lender a written acknowledgement from transferee that transferee has received such material and understands that Lender's security interest reflected by this Mortgage and the Security Agreement, if any, will remain on the Property and the Beneficial Interest, if any, until the entire outstanding principal balance of Borrower's line of credit as of the date of such sale or transfer or promise, plus any subsequent borrowing made under Borrower's line of credit before Lender has actual knowledge of the sale or transfer, together with accrued interest and other charges, is paid in full; (iii) Borrower causes to be submitted to Lender from the transferee a loan application as required by Lender so that Lender may evaluate the creditworthiness of the transferee as if a new loan were being made to the transferee; and (iv) Lender does not in its sole opinion, believe that (a) its security will be adversely affected, or (b) a breach of any promise or agreement in this Mortgage or the Security Agreement, if any, will occur or (c) such transfer will permit the acceleration of any loan which has priority in right of payment over the indebtedness evidenced by the Note. Further advances on the line of credit will cease as of the date of the written assumption agreement signed by the transferee and Lender. The transferee and Borrower shall retain the right to repay the Note before the final payment date set forth in Paragraph 4 of the Note, in whole or in part, at any time without premium or penalty.

17. ACCELERATION; REMEDIES (INCLUDING FREEZING THE LINE). Upon the existence of an Event of Default Lender may, at its sole option, terminate the line, declare all of the sums secured by this Mortgage to be immediately due and payable without further demand, and invoke any remedies permitted by applicable law.

22. TIME IS OF THE ESSENCE. Time is of the essence to this Mortgage and all provisions relating thereto are to be strictly construed.

27. INCONSEQUENCE OF TERMS. All of the terms, conditions and provisions of the Note are by this reference incorporated herein as if set forth in full. Any Event of Default under the Note shall constitute an Event of Default hereunder without further notice to Borrower.

REQUEST FOR NOTICES. Borrower requests that copies of any notice of default be addressed to 20. Borrower and sent to the Property Address. Lender requests that copies of notices of default, sale and foreclosure from the holder of any lien which has priority over this Mortgage be sent to Lender's address, as set forth on page one of this Mortgage.

19. RELEASE. Upon payment and discharge of all sums secured by this Mortgage and termination of the account, this Mortgage shall become null and void and Lender shall release this Mortgage without charge to Borrower.

Upon acceleration under Paragraph 17 hereof, or abandonment, Lessor at any time without notice, in person, by agent or by judicially appointed receiver, and without regard to the adequacy of any security for the indebtedness secured by this Mortgage, shall be entitled to enter upon, take possession of, and manage the Property, and in its own name sue for or collect the rents of the Property, including those past due. All rents collected by Lender or the receiver shall be entitled to enter upon, take possession of, and manage the Property, and in its own name sue for or collect the rents of the Property, including those past due. All rents collected by Lender or the receiver shall be liable to the collector and the Propertry and the collection of the rents shall not cure any upon and lacking possession of the Property and the collection of the rents shall not cure any Event of Default or notice of default hereunder or invalidate any act done puruant to such notice.

18. ASSIGNMENT OF RENTS; APPORTIONMENT OF RECEIPTS; LENDER IN POSSESSION. As additional security hereunder, Borrower hereby assigns to Lender the rents of the Property, provided that prior to acceleration under Paragraph 17 hereof or the occurrence of an Event of Default hereunder or abandonment of the Property, Borrower shall have the right to collect and retain such rents as they become due and payable.

If Lender reduces the line of credit, Lender shall notify Borrower, in the manner provided in Paragraph 11 of this Mortgage, within three (3) days after such action has been taken. Such notice shall specify: (i) the reasons for such action; (ii) the new credit limit, if the credit limit has been reduced; and (iii) that any reinstatement of the credit privilege must be requested by Borrower. Lender will reinstate the line of credit at Borrower's request if the event giving rise to such reduction or freeze no longer exists and no other event that would give Lender the right to freeze or reduce the line of credit or any Event of Default is then existing. If the line of Credit is frozen or reduced, Borrower is not obligated to repay the outstanding principal balance until the final payment date set forth in Paragraph 4 of the Note; provided, however, that Lender will still have the right, in accordance with the terms of the Note, to accelerate the final payment of the balance of the Note, to require immediate repayment of all amounts then due, and to exercise all other rights and remedies available to Lender under the Note and the terms of this paragraph.

As additional specific protection, notwithstanding any other term of the Note, Lender, without detracting or asserting any right to any future event of Default or any of its remedies pertaining to Events of Default, may cancel Borrower's credit standing and advances under the Note (that is "freeze" the line of credit), without requiring acceleration repayment of the outstanding principal balance, upon the occurrence and during the continuation of any of the following events: (i) the value of the property decedent significantly below the Property's appraised value for purposes of the Note; (ii) Lender reasonably believes that Borrower will be unable to fulfill the payment obligations under the Note because of a material change in Borrower's financial condition; (iii) the occurrence of an Event of Default; (iv) Lender is precluded by government from imposing the interest rate provided in the Note; (v) the priority of Lender's security interest in the Property under the Note; or (vi) Lender is notified by its regulator agency that the maximum interest rate permitted to be charged by Lender under the Note is reached.

25. **WAIVER OF STATUTORY RIGHTS.** Borrower shall not and will not apply for or avail itself of any homestead, appraisement, valuation, redemption, stay, extension, or exemption laws, or any so-called "moratorium laws", now existing or hereafter enacted, in order to prevent or hinder the enforcement or foreclosure of this mortgage, but hereby waives the benefits of such laws. Borrower, for itself and all who claim through or under it, waives any and all right to have the property and estates comprising the Property marshalled upon any foreclosure of the lien hereof and agrees that any court having jurisdiction to foreclose such lien may order the Property sold as an entirety. Borrower hereby waives any and all rights of redemption under any order or decree of foreclosure, pursuant to rights herein granted, on behalf of Borrower, all persons beneficially interested in the Property and each and every person acquiring any interest in or title to the Property or the Collateral subsequent to the date of this Mortgage, and on behalf of all other persons, to the extent permitted by Illinois law.

26. **EXPENSE OF LITIGATION.** In any suit to foreclose the lien of this Mortgage or enforce any other remedy of the Lender under this Mortgage or the Note or the Credit Documents there shall be allowed and included, as additional indebtedness in the judgment or decree, all expenditures and expenses which may be paid or incurred by or on behalf of Lender for attorney's fees, appraiser's fees outlays for documentary and expert evidence, stenographer's charges, publication costs, survey costs, and costs (which may be estimated as to items to be expended after entry of the decree) of procuring all abstracts of title, title searches and examinations, title insurance policies, Torrens certificates, and similar data and assurances with respect to title as Lender may deem reasonably necessary either to prosecute such suit or to evidence to bidders at any sale which may be had pursuant to such decree the true condition of the title to or value of the Property. All expenditures and expenses of the nature in this paragraph mentioned, and such expenses and fees as may be incurred in the protection of said Property and the maintenance of the lien of this Mortgage, including the fees of any attorney employed by Lender in any litigation or proceeding affecting this Mortgage, the Note or the Property or in preparation for the commencement or defense of any proceeding or threatened suit or proceeding, shall be immediately due and payable by Borrower, with interest thereon at the rate from time to time in effect under the Note with respect to revolving credit advances.


