5. Property Insurance. Borrower shall keep the improvements now existing or hereafter erected on the Property insured against loss by fire, hazards included within the term "extended coverage," and any other hazards including, but not limited to, earthquakes and floods, for which Lender requires insurance. This insurance shall be maintained in the amounts (including deductible levels) and for the periods that Lender requires. What Lender requires pursuant to the preceding sentences can change during the term of the Loan. If Borrower abandons the Property, Lender may file, negotiate and settle any available insurance claim and related matters. If Borrower does not respond within 30 days to a notice from Lender that the insurance carrier has offered to settle a claim, then Lender may negotiate and settle the claim. The 30-day period will begin when the notice is given. In either event, or if Lender acquires the Property under Section 22 or otherwise, Borrower hereby assigns to Lender (a) Borrower's rights to any insurance proceeds in an amount not to exceed the amounts unpaid under the Note or this Security Instrument, and (b) any other of Borrower's rights (other than the right to any refund of unearned premiums paid by Borrower) under all insurance policies covering the Property, insofar as such rights are applicable to the coverage of the Property. Lender may use the insurance proceeds either to repair or restore the Property or to pay amounts unpaid under the Note or this Security Instrument, whether or not then due.

If Lender required Mortgage Insurance as a condition of making the Loan and Borrowe, was required to make separately designated payments toward the premiums for Mortgage Insurance, Eoryower shall pay the premiums required to maintain Mortgage Insurance in effect, or to provide a non-refundable loss reserve, until Lender's requirement for Mortgage Insurance ends in accordance with any written agreement between Borrower and Lender providing for such termination or until termination is required by Applicable Law. These agreements may require the mortgage insurer to make payments using any source of funds that the mortgage insurer may have available (which may include funds obtained from Mortgage Insurance premiums).

As a result of these agreements, Lender, any purchaser of the Note, another insurer, any reincurer, any other entity, or any affiliate of any of the foregoing, may receive (directly or indirectly) amounts that derive from (or might be characterized as) a portion of Borrower's payments for Mortgage Insurance, in exchange for sharing or modifying the mortgage insurer's risk, or reducing losses. If such agreement provides that an affiliate of Lender takes a share of the insurer's risk in exchange for a share of the premiums paid to the insurer, the arrangement is often termed "captive reinsurance." Further:

(a) Any such agreements will not affect the amounts that Borrower has agreed to pay for Mortgage Insurance, or any other terms of the Loan. Such agreements will not increase the amount Borrower will owe for Mortgage Insurance, and they will not entitle Borrower to any refund.

These rights may include the right to receive certain disclosures, to request and obtain cancellation of the Mortgage Insurance, to have the Mortgage Insurance terminated automatically, and/or to receive a refund of any Mortgage Insurance premiums that were unearned at the time of such cancellation or termination.





- 22. Acceleration; Remedies. 



SECURITY INSTRUMENT RIDER (PREPAYMENT PENALTY)

This Security Instrument Rider is incorporated into and shall be deemed to amend and supplement the Mortgage, Flust Deed, Deed of Trust, or Security Deed (the "Security Instrument") of the same date executed by the undersigned to secure Borrower's Fixed Rate Note or Adjustable Rate Note, as applicable (the "Note") payable to CCPLEY FINANCIAL CORPORATION

(the "Lender").

Additional Covenants. In addition to the covenants and agreements made in the Security Instrument, the Lender and I further covenant and agree as follows:

Paragraph 1 of the Security Instrument shall be modified to read as follows:

1. PAYMENT OF PRINCIPAL AND IN EREST; PREPAYMENT AND LATE CHARGES.

I will promptly pay when due the principal of and interest on the debt evidenced by the Note and any prepayment and late charges due under the Note.

I will have the right to make payments of principal at 2.1 time before they are due. A payment of principal only is known as a "prepayment." When I make a prepayment, I will tell the Lender in writing that I am doing so.

The first thirty-six months of the loan term is called the "Penalty reriod." In any twelve month period during the Penalty Period, I may prepay up to 20% of the original principal amount of the Note without paying a penalty. (B) The Index
