TERMS AND CONDITIONS

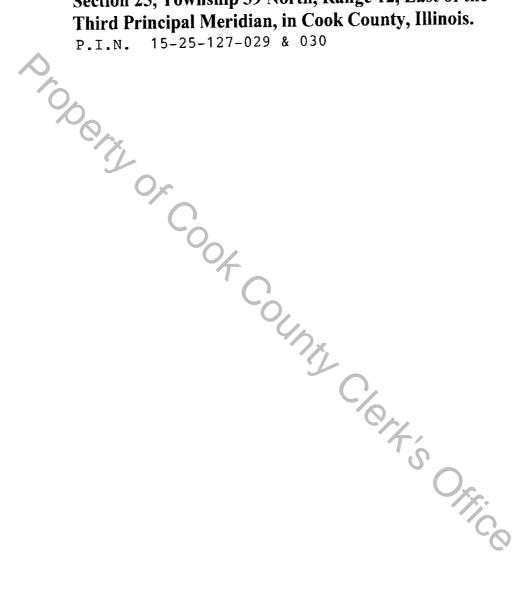
