THIS AGREEMENT is entered into this 10th day of October 2002, by Vintage Mortgage ("the Lender") and Suburban Bank & Trust Co. ("Lienholder").

Recitals

- 1. <u>Subordination</u>. Lien holder agrees to and hereby does subcrd nate its second mortgage lien in the property to a new First Mortgage Lien to be filed by the Lender in order to refinance its existing First Mortgage.

The Lender agrees that Lien holder's Second Mortgage shall in no way be impaired or affected by this agreement except that the Second Mortgage Lien shall stand Junior and Subordinate to the Lender's new First Mortgage in he same manner and to the same extent as if the Lender's new First Mortgage had been filed prior to the execution and recording of the Lienholder's Second Mortgage.
- 3. At no time, without Lien holder's written consent, should the principal amount secured by Lender's First Mortgage exceed the original principal amount of \$206,000.00
