

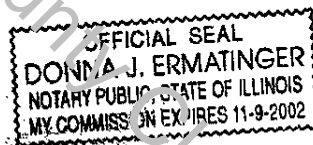

JUDGMENT

On the 05 day of April, 2000, came on to be heard the trial of the above-referenced matter. Plaintiff appeared in person and by and through counsel. Defendant, though duly cited to appear and answer herein, has failed to answer or to appear and has wholly made default. After reviewing the file in this case, considering the pleadings and hearing the evidence and arguments of counsel, the court finds that Defendant, Bernard Kane, has been duly served with process in this case, that the return of service of process on the Defendant has been on file for the time prescribed by law and that the Court has jurisdiction of this case, and the Court is of the opinion that judgment should be rendered in favor of Plaintiff and against Defendant.

It is, therefore, ordered, adjudged and decreed that Plaintiff, Harold B. Berman, do hereby have and recover judgment against Defendant, Bernard Kane, in the sum of \$2,054.66.

It is further ordered, adjudged and decreed that in addition to the above award, Plaintiff, Harold B. The attorneys' fees awarded herein shall be and are a part of the judgment hereby rendered. All such attorneys' fees are reasonable in relation to the work performed.
