RECITALS:

WHEREAS, Lender has heretofore made a construction mortgage loan (the "Loan") to Borrower in the original principal amount of TWO MILL'ON ONE HUNDRED EIGHTY NINE THOUSAND AND 00/100 DOLLARS (\$2,189,000.00); and

WHEREAS, the Loan is evidenced by a Construction Mc tgage Note dated as of October 11, 2002 (the "Note") made by Borrower whereby Borrower promised to pay to the order of Lender the principal sum of TWO MILLION ONE HUNDRED EJC HTY NINE THOUSAND AND 00/100 DOLLARS (\$2,189,000.00), all as more specifically set forth in said Note; and

WHEREAS, the Note is secured by, among other things, a Construction Mortgage, Assignment of Leases and Rents, and Security Agreement dated as of the 11th day of October, 2002 by Borrower in favor of Lender, recorded in the Office of the Recorder of Deeds o Cook County, Illinois, on October 28, 2002 as Document No. 0021184112; and any and all other instruments and documents executed by or on behalf of Borrower and delivered to Lender in connection with the Loan, which are hereinafter collectively referred to as the "Other Security Documents"; and

WHEREAS, Borrower desires that the Loan be modified to extend the Maturity Date; and

WHEREAS, the parties desire to modify and amend the Loan as provided herein and as a condition to such modification, Lender is requiring: (i) this Amendment; and (ii) a Modification of Construction Mortgage and Other Security Documents dated of even date herewith executed by Borrower (the "Mortgage Modification"), whereby the Mortgage and the other documents evidencing and securing the Loan (the "Other Security Documents") are modified to secure the Note as modified hereby.

NOW, THEREFORE, for and in consideration of Ten and 00/100 Dollars (\$10.00) in hand paid, the mutual covenants and conditions herein contained, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto do hereby agree as follows:

- 1. Incorporation of Recitals. The aforesaid recitals are hereby incorporated into this Modification by reference as if fully set forth in this Paragraph 1. Wherever the terms and conditions of this Modification conflict with the terms and conditions of the Mortgage, the terms and conditions of this Modification shall control. In all other respects the parties do hereby ratify and declare to be in full force and effect the terms and conditions of the Mortgage and the Other Security Documents.
- 2. Mora ration of Mortgage and Other Security Documents. The Mortgage and Other Security Documents are hereby modified by deleting therefrom the amount "April 10, 2004" where it appears and substituting therefor "June 30, 2004."
- 3. References to Note From and after the date hereof (i) the Mortgage, the Assignment and the Other Securi y Documents shall be deemed to secure the Note as modified by the Note Amendment; and (ii) any and all references in the Mortgage or the Other Security Documents to the "Note" shall be decreed to refer to the Note as modified by the Note Amendment.
- 4. References to Loan Documents. Any and all references in the Note, the Mortgage and the Other Security Documents to the "Loan Documents" shall from and after the date hereof be deemed to refer to such Loan Documents as modified by this Modification.
- 5. **Reaffirmation of Representations and Warrancies**. Mortgagor hereby reaffirms as true and correct in all respects, as of the date hereof, any and all representations and warranties contained in the Mortgage and the Other Security Documents.
- 6. **Reaffirmation of Covenants**. Mortgagor does hereby reaffirm and agree to perform all of the terms, covenants, conditions and obligations applicable to such parties as set forth in the Mortgage and the Other Security Documents as herein modified.
- 7. **Laws of Illinois**. This Modification shall be covered and construed under the laws of the State of Illinois.
