

## FIRST AMENDMENT TO THE DECLARATION OF CONDOMINIUM OF THE BUENA POINTE CONDOMINIUM

- 1. The Plat of Survey labeled as Exhibit "D" to the Dcclaration is hereby deleted.
- 2. That the Plat of Survey attached hereto and marked as Exribit "D" is hereby made a part of the Declaration as Exhibit "D" as required by the Act.
- 3. That except as modified herein, all other provisions of the Declaration shall remain in full force and effect.
