The 30-day period will begin when the notice is given. 1. Preservation, Maintenance and Protection of the Property; Inspections. Borrower shall not destroy, Lomage or impair the Property, allow the Property to deteriorate or commit waste on the Property. 9. Protection of Lender's Interest in the Property and Rights Under this Security Instrument.
