commonly known as 3610 St. Paul Avenue (15-09-317-069), Bellwood, Illinois.

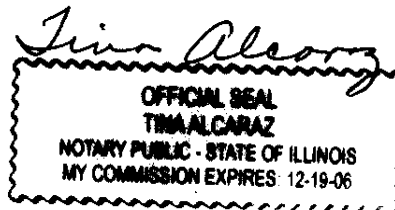

Bellwood, a subdivision of that part of the East 1/2 of the South West 1/4 lying south of the center line of Butterfield Road, except of the right of way of the C. St. P. & K. C. R. R. and except a piece of land bounded as follows: Commencing at the intersection of the center of Butterfield Road with the West line of the East 1/2 of the South West 1/4 thence South on said West line 302.48 feet, thence Northeasterly parallel with the center line of Butterfield Road 302.48 feet, thence North parallel with the West line of the East 1/2 of the Southwest 1/4 302.48 feet to the center of Butterfield Road, thence Southwesterly of the center line of the road 302.48 feet to place of beginning; also that part of the West 1/2 of the South West 1/4 lying South of the center line of Butterfield Road and North of the railroad except therefrom the following: Commencing at the intersection of the center line of Butterfield Road and the East line of the West 1/2 of the Southwest 1/4 thence South of said East line 208.5 feet, thence Southwesterly parallel with the center line of Butterfield Road 208.5 feet, thence North parallel with the East line of the West 1/2 of the Southeast 1/4 208.5 feet to the center line of Butterfield Road, thence Northeasterly on the center line of said road 208.5 feet to place of beginning in Section 9, Township 39 North, Range 12, East of the Third Principal Meridian, in Cook County, Illinois.
