ORDINANCE NO. 04- 0-10

AN ORDINANCE ANNEXING CERTAIN TERRITORY TO THE TINLEY PARK PARK DISTRICT (Kimberly Heights Subdivision)

WHEREAS, the President and Board of Trustees of the Village of Tinley Park in multiple ordinances, attached hereto as Exhibit A, annexed certain territory legally described herein (the "Territory");
