

ORDINANCE TO VACATE PERPETUAL EASEMENT ON MARION STREET NORTH OF LAKE STREET

ORIGINAL

BE IT ORDAINED by the President and Board of Trustees of the Village of Cook County, Illinois, as follows:

SECTION 1: That it is hereby determined that the public will be sub served by vacating the easement granted to the Village of Oak Park hereinafter described:

SECTION 2: The easement granted to the Village of Oak Park hereinafter described was granted by Oak Park Trust and Savings Bank in Document Number 22982203 recorded with the Cook County Recorder of Deeds for a street turnaround and walkway on Marion Street when the Lake Street Right-of-Way was solely a pedestrian mall without a street.

SECTION 3: The easement granted to the Village of Oak Park has not been used since the Lake Street Right-of-Way became a street and not solely a pedestrian mall.

SECTION 4: The easement to be vacated is described as follows:

That part of Lots 5 and 6, taken as a tract, described as follows. Beginning at a point on the West line of said Lot 5, said point being 20.75 feet North of the Southwest corner of said lot; thence East perpendicularly to said West line 27.00 feet; thence South along a line parallel with the West line of said tract 78.00 feet thence West perpendicularly to the West line of said tract 27.00 feet to a point on said West line; thence North along said west line 57.25 feet to the place of beginning, all in Konn's Subdivision of Lot 5 and the North 310 feet of the East 32.44 feet of Lot 6 of Skinner's subdivision of Land in the Southwest corner of the Northwest ¼ of Section 7, Township 39 North, Range 13 East of the Third Principal Meridian, and of the East 67.3 feet of Lot 4 and the West 47.87 feet of Lot 3 in Block 8 of Kettlestring's Addition to Harlem, in Cook County, Illinois.




