ASSIGNMENT AND ASSUMPTION OF REGULATORY AGREEMENT

THIS ASSIGNMENT AND ASSUMPTION OF REGULATORY AGREEMENT (this "Assignment") is made and entered into as of the 16th day of June, 2004, by and among LASALLE BANK, NATIONAL ASSOCIATION, as successor trustee (the "Trustee") to LaSalle National Trust, N.A. as successor trustee to LaSalle National Bank, not personally but as Trustee under a Trust Agreement dated September 24,1979 and known as Trust No. 101783 (the "Trust"), having its principal office at 135 \$\infty\$ aSalle St., Chicago, Illinois; PARKWAYS ASSOCIATES LIMITED PARTNERSHIP, an Illinois limited partnership and the sole beneficiary of the Trust (the "Partnership"), having its rancipal office c/o Apartment Investment and Management Company at Stanford Place 3, 4582 South Ulster Street Parkways, Suite 1100, Denver, Colorado 80237; PARKWAYS PRESERVATION, L.P., a Delaware limited partnership (the "Buyer") having its principal office c/o Apartin in Investment and Management Company at Stanford Place 3, 4582 South Ulster Street Parkways, Svite 1100, Denver, Colorado 80237; and ILLINOIS HOUSING DEVELOPMENT AUTHORITY, a body politic and corporate created by and existing pursuant to the Illinois Housing Development Act, 20 ILCS 3805/1 et seq., as amended from time to time (the "Authority"); the Trustee and the Partnership are collectively referred to in this Assignment as the "Seller".

RECITALS

- The Seller is the sole owner of a multi-family housing development known as The A. Parkways, located on the real estate legally described in Exhibit A attached to and made a part of this Assignment (the "Real Estate"). The Trustee holds fee title to the Development. The Real Estate and the improvements constructed on it are collectively referred to in this Assignment as the "Development".
- The Authority has previously made two mortgage loans to the Seller in the original В. principal amounts of Twenty-Eight Million One Hundred Seventy-Six Thousand Four Hundred Forty Six and 18/100 Dollars (\$28,176,446.18) for the acquisition, construction

and permanent financing of the Development. The Loan is evidenced by two Notes dated May 1, 1994, both made by the Trustee in favor of the Authority; secured by a mortgage dated May 1, 1994, given by Trustee in favor of the Authority, and recorded in the Office of the Recorder of Deeds of Cook County, Illinois (the "Recorder's Office") as Document No. 94478796 on May 27, 1994; and governed by that certain Regulatory Agreement and Declaration of Restrictive Covenants among the Trustee, the Partnership and the Authority dated as of May 1, 1994, and recorded in the Recorder's Office as Document No. 94478795 on May 27, 1994 (the "Regulatory Agreement").

- C. The Seller desires to sell, assign, transfer and convey to the Buyer, and the Buyer desires to purch se from the Seller, all of the Seller's right, title and interest in the Development (the "Transfer"). It is a condition of the Authority's approval of the Transfer, among other things that the Seller assign, and that the Buyer assume, the Seller's obligations pursuant to the Regulatory Agreement.
- D. It is a condition of the Authority's approval of the Transfer, among other things, that the Seller assign, and that the Buyer assume, the Seller's obligations under the Regulatory Agreement.

NOW, THEREFORE, in consideration of the mutual promises contained in this Assignment and other good and valuable consideration, receipt of which is acknowledged, the parties agree as follows:

- 1. Recitals. The recitals set forth above are incorporated into this Assignment by this reference.
- 2. <u>Assignment of Regulatory Agreement</u>. The Seller assigns and transfers to the Buyer, its successors and assigns all of its rights, duties, obligations and interest under the Regulatory Agreement; subject, however, to any limitations on assignment set forth therein.
- 3. Acceptance of Assignment. The Buyer, for itself, its successors and assigns, agrees to be bound by all of the terms, conditions, obligations and restrictions set forth in the Regulatory Agreement, to the same extent and on the same terms as the Scher; however, the Buyer shall not be so obligated with respect to matters that were required to be performed prior to the date of this Assignment. It is the intent of the parties that, as of the date of this Assignment, the Buyer now be treated as the owner of the Development under the terms of the Regulatory Agreement.
- 4. No Release. Nothing in this Agreement shall act as a release or waiver of any claim that may arise in connection with the Seller's failure to have faithfully discharged all of its duties and responsibilities under the Regulatory Agreement prior to the date of this Assignment. However, the Seller shall have no obligation for the performance of any rights, duties and obligations that accrue under the Regulatory Agreement, as amended by this Assignment, subsequent to the date of this Assignment.

- Amendment of Agreement. This Assignment shall not be altered or amended without 5. the prior written approval of all of the parties to it.
- Partial Invalidity. If a court of competent jurisdiction determines that any term, 6. covenant, condition or provision of this Assignment, or its application to any circumstance, at any time or to any extent, is invalid or unenforceable, the remainder of this Assignment, or the application of it to circumstances other than those as to which it is held invalid or unenforceable, shall not be affected by such determination and each term, covenant, condition and provision of this Assignment shall be valid and enforceable to the fullest extent permitted by law.
- Successors. Subject to the provisions of Paragraphs 5& 6 hereof, this Assignment shall 7. bind, and be benefits shall inure to, the parties to this Assignment, their legal representatives cuccessors in office or interest and assigns; however, the Buyer may not assign this Assignment, or any of its obligations under this Assignment, without the prior written approval of the Authority.
- The captions used in this Assignment are used only as a matter of 8. convenience and for reference and in no way define, limit or describe its scope or intent.
- Notices.
