**AGREED ORDER OF INJUNCTION, AND OF JUDGMENT AND ENFORCEMENT WITH SETTLEMENT**

THIS CAUSE coming on to be heard by the Court, the Court having heard evidence and testimony; IT IS HEREBY ORDERED THAT:

1. The judgment entered on the date of 5/17/04 in the amount of \$ 1200.00 plus \$60.00 court costs for a total of \$ 1260.00 against Defendant(s) Federal Home Loan Mortgage Corporation shall stand as final judgment on Count I of Plaintiff's complaint. Leave to enforce said judgment is stayed until 6/16/04. Execution is to issue on the judgment thereafter. Count I is dismissed as to all other defendants not named in this paragraph 1.

2. Plaintiff agrees to accept \$ 600.00 in full settlement of the judgment if payment is made to the City of Chicago by 6/17/04. If payment is mailed it must be postmarked within the aforesaid time limit and mailed to the attention of Tina Zvanjd at 30 N. LaSalle St., Room 700, Chicago, IL 60602.

3. Defendant(s) Federal Home Loan Mortgage Corp. and his/her/their agents, heirs, successors and/or assigns:

shall correct violations \_\_\_\_\_ at the subject premises as cited in the City's complaint by \_\_\_\_\_.

bring the subject premises into full compliance with all items cited in the City's complaint by: 11/17/04.

be permanently enjoined and restrained from renting, using, leasing, or occupying the entire subject property until full compliance with the Municipal Code and further order of court, and shall keep said portions of the premises in a vacant, safe and secure condition.

4. Defendant(s) shall call the inspector at 746-8510 to schedule an inspection 7 days after each compliance date in this order.

5. ~~The default judgment entered on 3/22/04 in the amount of \$10,000 is hereby vacated~~

5. The court reserves jurisdiction of this matter for the purposes of modification, enforcement or termination of this order, including the adjudication of contempt proceedings, which could result in the imposition of a fine and/or incarceration.

6. Any and all other counts and defendants in this cause are hereby dismissed. This order is final, appealable, and enforceable, the court finding no just cause or reason to delay its enforcement or appeal.
