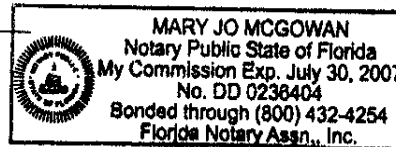

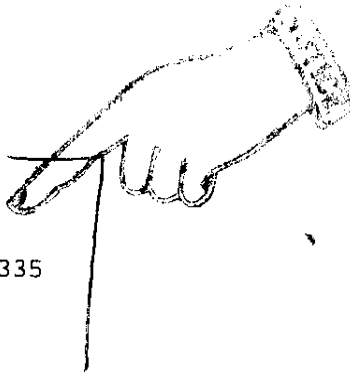

MORTGAGE

THIS MORTGAGE ("Security Instrument") is given on January 29th, 1999. The mortgagor is HARRY W. GUSTAFSON and DONNA D. GUSTAFSON, HUSBAND AND WIFE
