MEMORANDUM OF JUDGMENT


I, Donald Martin, the Plaintiff in the above captioned case, on oath depose and state as follows:

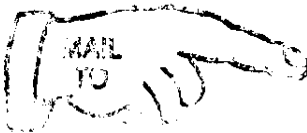
